Senate Bill 159 (Senator Ellis) Education, Energy, and the Environment

State Designations - State Fruit - American Persimmon

This bill designates the American Persimmon as the State fruit.

Fiscal Summary

State Effect: Designating a State fruit does not materially affect State finances.

Local Effect: None.

Small Business Effect: None.

Analysis

Current Law: Since the adoption of the Maryland State Flag in 1904 and the adoption of the Black-eyed Susan as the State flower in 1918, the State has adopted many official symbols, as shown in **Exhibit 1**. The Governor is also authorized to designate a citizen as the State's Poet Laureate.
