AMENDMENTS TO HOUSE BILL 1300  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, after “appointee” insert “and is in the skilled service in the State Personnel Management System”.

AMENDMENT NO. 2

On page 2, in line 7, after “director” insert “:

**(1)**;

in the same line, after “Department” insert “;AND

**(2) IS IN THE SKILLED SERVICE IN THE STATE PERSONNEL MANAGEMENT SYSTEM**”;

in lines 14 and 15, strike “AND OUT OF THE HOME” and substitute “**SOCIETY**”; in line 15, after “directing” insert “**CRITICAL**”; strike beginning with “as” in line 15 down through “workers” in line 16 and substitute “**IN THEIR VARIOUS ROLES**”; in line 22, after “**(III)**” insert “**CONDUCT RESEARCH ON ISSUES THAT IMPACT WOMEN AND IDENTIFY EXISTING DISPARITIES**”;

**(IV)**”;

in lines 25 and 27, strike “**(IV)**” and “**(V)**”, respectively, and substitute “**(V)**” and “**(VI)**”, respectively; in line 27, strike “**PROVIDE PUBLICITY FOR**” and substitute “**RAISE PUBLIC AWARENESS OF**”; in line 28, strike “**PERSONAL GROWTH AND**

DEVELOPMENT” and substitute “ECONOMIC SECURITY”; and in line 29, strike “CAREER-RELATED ISSUES” and substitute “WOMEN’S HEALTH”.

On page 3, in lines 1, 3, 10, 12, and 16, strike “(VI)”, “(VII)”, “(IX)”, “(X)”, and “(XI)”, respectively, and substitute “(VII)”, “(VIII)”, “(X)”, “(XI)”, and “(XII)”, respectively; in line 1, after “ASSIST” insert “STATEWIDE WOMEN’S ORGANIZATIONS, LOCAL COMMISSIONS FOR WOMEN, AND”; strike beginning with “WAGE” in line 3 down through “FOSTERING” in line 4 and substitute “WOMEN’S ECONOMIC EMPOWERMENT, WOMEN’S HEALTH, CULTURAL DEVELOPMENT,”; in line 5, strike “AND HUMAN RELATIONS”; strike in their entirety lines 7 through 9, inclusive, and substitute:

**“(IX) RECOMMEND STRATEGIES TO REDUCE DISCRIMINATION AND INCREASE OPPORTUNITIES FOR WOMEN IN EMPLOYMENT, EDUCATION, THE LAW, STATE GOVERNMENT, AND ELECTED AND APPOINTED POSITIONS ACROSS PROFESSIONS AND WITHIN SOCIETY;”**;

and in line 10, strike “OFFER” and substitute “SUPPORT PARTNER ORGANIZATION”.
