AMENDMENTS TO SENATE BILL 820
(First Reading File Bill)

On page 4, strike beginning with “DESCRIBED” in line 18 down through “ARTICLE” in line 21 and substitute “, THAT DOES NOT COMPLY WITH SUBTITLE 2E OF THE HEALTH – GENERAL ARTICLE”; in line 22, after “PRODUCT” insert a comma; and strike beginning with “THAT” in line 23 down through “ARTICLE” in line 26 and substitute “, THAT DOES NOT COMPLY WITH TITLE 21, SUBTITLE 2F OF THE HEALTH – GENERAL ARTICLE”.

On page 5, in line 3, after “ARTICLE” insert “AND IS DESIGNATED BY THE SECRETARY OF HEALTH FOR ENFORCEMENT BY THE EXECUTIVE DIRECTOR”; in line 8, strike “AND”; strike in their entirety lines 11 through 13, inclusive; in lines 14, 15, 16, and 17, strike “(IV)”, “(V)”, “(VI)”, and “(VII)”, respectively, and substitute “(I)”, “(II)”, “(III)”, and “(IV)”, respectively; in line 17, after “HCL” insert “; AND”

(3) A PRODUCT REPRESENTED TO CONTAIN KRATOM, 7-HYDROXYMITRAGYNINE, OR ANY PART OF THE PLANT MITRAGYNA SPECIOSA THAT IS:

(I) LABELED OR ADVERTISED IN VIOLATION OF § 21-2E-02 OR § 21-2E-03 OF THE HEALTH – GENERAL ARTICLE; OR

(II) LABELED, ADVERTISED, OR OTHERWISE REPRESENTED TO CONTAIN MORE THAN ONE MILLIGRAM PER SERVING OF 7-HYDROXYMITRAGYNINE”;

in line 21, strike “WAS APPROVED” and substitute “IS:”

**(1) IF APPLICABLE, IN COMPLIANCE WITH TITLE 21, SUBTITLE 2E
OF THE HEALTH – GENERAL ARTICLE; OR**

(2) AUTHORIZED”;

in line 23, strike “(1)” and substitute “(I)”; and in line 24, strike “(2)” and substitute “(II)”.

On page 8, strike beginning with the colon in line 19 down through “The” in line 20 and substitute “THE”; and strike beginning with “; and” in line 21 down through “consumer” in line 23.

On page 13, in line 14, strike “KRATOM” and substitute “PHENIBUT”; and in line 25, after “product” insert “for enforcement by the Executive Director of the Alcohol, Tobacco, and Cannabis Commission”.
