AMENDMENTS TO HOUSE BILL 1  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate Crosby**” and substitute “**Delegates Crosby, Allen, Amprey, Bagnall, Behler, Boaf, Cardin, Edelson, Foley, Forbes, Fraser-Hidalgo, Guyton, Healey, Kaufman, Korman, Lewis, J. Long, Moon, Odom, Phillips, Ruff, Shetty, Solomon, Stein, Toles, and Watson**”; strike beginning with “prohibiting” in line 4 down through “circumstances,” in line 6; and in line 10, after “expenditures,” insert “requiring the Public Service Commission to publish certain guidance; requiring each public service company to send a copy of the policy adopted under this Act to the Commission at certain times;”.

AMENDMENT NO. 2

On page 2, in line 15, strike “**A SUPERVISOR**” and substitute “**AN EMPLOYEE OF A PUBLIC SERVICE COMPANY, THE PARENT COMPANY OF A PUBLIC SERVICE COMPANY, OR ANY OTHER AFFILIATE OF A PUBLIC SERVICE COMPANY**”; in line 16, strike “**SUPERVISOR’S**” and substitute “**EMPLOYEE’S**”; in line 27, after “**MEDICAL,**” insert “**DENTAL, VISION,**”; in line 29, strike “**INDIVIDUAL**” and substitute “**EMPLOYEE OF A PUBLIC SERVICE COMPANY, THE PARENT COMPANY OF A PUBLIC SERVICE COMPANY, OR ANY OTHER AFFILIATE OF A PUBLIC SERVICE COMPANY**”; and in line 30, strike “**INDIVIDUAL’S**” and substitute “**EMPLOYEE’S**”.

On page 3, in line 1, strike “**INDIVIDUAL’S**” and substitute “**EMPLOYEE’S**”; in line 18, after the semicolon insert “**OR**”; strike in their entirety lines 19 and 20; in line 21, strike “**(4)**” and substitute “**(3)**”; in line 22, strike “**A MEMBER**” and substitute “**THE CHAIR**”; and strike in their entirety lines 24 through 29, inclusive.

On page 4, in line 1, strike “(E)” and substitute “(D)        (1)”; in lines 4, 5, 6, 7, 8, and 9, strike “(1)”, “(2)”, “(3)”, “(4)”, “(5)”, and “(6)”, respectively, and substitute “(I)”, “(II)”, “(III)”, “(IV)”, “(V)”, and “(VI)”, respectively; in line 2, after “LIMITATIONS” insert “, IN ACCORDANCE WITH GUIDANCE PUBLISHED BY THE COMMISSION UNDER PARAGRAPH (2) OF THIS SUBSECTION,”; in line 3, after “EXPENDITURES” insert “THAT THE PUBLIC SERVICE COMPANY INTENDS TO RECOVER THROUGH RATES”; after line 10, insert:

“(2) THE COMMISSION SHALL PUBLISH GUIDANCE DEFINING “REASONABLE COST LIMITATIONS” FOR EXPENDITURES UNDER THIS SUBSECTION.

“(3) EACH PUBLIC SERVICE COMPANY SHALL SEND A COPY OF THE POLICY ADOPTED UNDER PARAGRAPH (1) OF THIS SUBSECTION TO THE COMMISSION:

(I) AS SOON AS PRACTICABLE; AND

(II) EACH TIME THE POLICY IS UPDATED, BUT NOT LESS THAN EVERY 5 YEARS.”;

and in line 12, strike “October” and substitute “June”.
