AMENDMENTS TO SENATE BILL 61
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Release Preparation**” and substitute “**Volunteer Services**”; in line 3, strike “Release Preparation” and substitute “**Volunteer Services**”; in line 4, after “to” insert “**volunteers, including**”; in the same line, after “individuals” insert “**and organizations led by formerly incarcerated individuals,**”; strike beginning with “altering” in line 6 down through the semicolon in line 8; in line 8, strike “Release Preparation” and substitute “**Volunteer Services**”; and strike in their entirety lines 9 through 13, inclusive.

AMENDMENT NO. 2

On pages 1 through 3, strike in their entirety the lines beginning with line 21 on page 1 through line 9 on page 3, inclusive.

AMENDMENT NO. 3

On page 3, in lines 12 and 14, in each instance, strike “**RELEASE PREPARATION**” and substitute “**VOLUNTEER SERVICES**”; in line 16, strike “**(1)**”; in line 17, after “**REGISTERING**” insert “**VOLUNTEERS, INCLUDING**”; in the same line, after “**INDIVIDUALS**” insert “**AND ORGANIZATIONS LED BY FORMERLY INCARCERATED INDIVIDUALS,**”; strike in their entirety lines 20 through 22, inclusive; in line 25, strike “**FORMERLY INCARCERATED INDIVIDUALS**” and substitute “**VOLUNTEERS**”; in line 26, strike “**MADE AVAILABLE TO THE PUBLIC**” and substitute “**MAINTAINED BY THE DIVISION OF CORRECTION**”; in the same line, strike “**AND**”; in line 27, after “**TO**” insert “**DECIDE WHETHER:**”

(1) THE INDIVIDUAL’S NAME IS MADE AVAILABLE TO THE PUBLIC; OR

(II) SUBJECT TO SUBSECTION (F) OF THIS SECTION, ANOTHER VOLUNTEER OR AN ORGANIZATION WILL PROVIDE THAT VOLUNTEER'S NAME OR THE NAME OF THE ORGANIZATION ON BEHALF OF THE FORMERLY INCARCERATED INDIVIDUAL TO BE MADE AVAILABLE TO THE PUBLIC; AND

(3) A VOLUNTEER IN THE PROGRAM TO;

and in line 29, strike "INDIVIDUAL" and substitute "VOLUNTEER".

On page 4, in line 1, strike "(D)(2)" and substitute "(D)(3)"; and after line 2, insert:

"(F) (1) IF A FORMERLY INCARCERATED INDIVIDUAL DOES NOT WANT THE FORMERLY INCARCERATED INDIVIDUAL'S NAME MADE AVAILABLE TO THE PUBLIC, ANOTHER VOLUNTEER OR AN ORGANIZATION MAY PROVIDE THAT VOLUNTEER'S NAME OR THE NAME OF THE ORGANIZATION ON BEHALF OF THE FORMERLY INCARCERATED INDIVIDUAL.

(2) THE DIVISION OF CORRECTION SHALL MAINTAIN A RECORD OF THE NAMES OF FORMERLY INCARCERATED INDIVIDUALS WHO HAVE ANOTHER VOLUNTEER OR AN ORGANIZATION PROVIDE THEIR NAME FOR PURPOSES OF SUBSECTION (D)(2)(II) OF THIS SECTION."
