AMENDMENTS TO HOUSE BILL 222

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Educational Institutions**” and substitute “**County Boards of Education**”; strike beginning with “requiring” in line 5 down through the semicolon in line 7; in line 8, strike “and certain institutions of higher education”; in line 10, strike “individuals” and substitute “high school students”; in line 13, strike “educational institutions” and substitute “county boards of education”; in line 16, strike “7-411 and”; and strike in their entirety lines 19 through 27, inclusive.

On page 2, strike line 1 in its entirety.

AMENDMENT NO. 2

On page 2, strike in their entirety lines 5 through 26, inclusive; in line 30, strike the brackets; in the same line, strike “and”; and in line 31, strike “**AN INDIVIDUAL ACTING IN GOOD FAITH**” and substitute “**, AND A HIGH SCHOOL STUDENT IN ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION**”.

On page 3, in line 1, strike “located on school property”; in line 3, after “(b)” insert “**(1)**”; in lines 4, 7, and 10, strike “(1)”, “(2)”, and “**(3)**”, respectively, and substitute “**(I)**”, “**(II)**”, and “**(III)**”, respectively; in line 10, after the first “A” insert “**HIGH SCHOOL**”; strike beginning with the comma in line 10 down through “ACTIVITY” in line 12 and substitute “**WHO HAS RECEIVED TRAINING ON THE APPROPRIATE USE OF NALOXONE OR OTHER OPIOID OVERDOSE-REVERSING MEDICATION**”; after line 13, insert:

“(2) THE POLICY ESTABLISHED UNDER SUBSECTION (A) OF THIS SECTION MAY INCLUDE A RECORD OF STUDENTS WHO INTEND TO POSSESS

NALOXONE OR OTHER OPIOID OVERDOSE-REVERSING MEDICATION AND WHETHER THOSE STUDENTS HAVE RECEIVED APPROPRIATE TRAINING.”;

in lines 14, 15, 18, and 22, in each instance, strike the bracket; in line 15, strike “INDIVIDUAL WHO RESPONDS”; strike beginning with the first comma in line 16 down through “SCHOOL” in line 17; in line 21, strike “or”; and in line 22, after “personnel” insert “; OR

(4) A HIGH SCHOOL STUDENT WHO HAS RECEIVED TRAINING ON THE APPROPRIATE USE OF NALOXONE OR OTHER OPIOID OVERDOSE-REVERSING MEDICATION”.

On pages 4 through 6, strike in their entirety the lines beginning with line 23 on page 4 through line 15 on page 6, inclusive.
