AMENDMENTS TO HOUSE BILL 972
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, after “**Miller,**” insert “**Buckel,**”; in the same line, after “**Pippy,**” insert “**Jacobs,**”; in the same line, strike “**Fair,**”; in the same line, strike “**Simpson,**”; in the same line, strike “**and Wivell**” and substitute “**Wivell, Adams, Anderson, Arentz, Arikan, Baker, Beauchamp, Chisholm, Ghrist, Griffith, Hartman, Hinebaugh, Howard, Hutchinson, Kipke, R. Long, Mangione, McComas, Metzgar, M. Morgan, T. Morgan, Nkongolo, Reilly, Schmidt, Stonko, Fair, Simpson, Allen, Behler, Boyce, Foley, Fraser-Hidalgo, Guyton, Healey, Holmes, J. Long, Korman, Lewis, Odom, Stein, and Ziegler**”; in line 3, strike “**Maryland Fair and**” and substitute “**Charles J. Otto**”; and strike beginning with “**requiring**” in line 7 down through the semicolon in line 10.

AMENDMENT NO. 2

On page 2, strike in their entirety lines 11 through 25, inclusive.

On page 3, strike beginning with “**REVENUE**” in line 11 down through “**(2)**” in line 13; in lines 14 and 15, strike “**(3)**” and “**(4)**”, respectively, and substitute “**(2)**” and “**(3)**”, respectively; and after line 27, insert:

“(1) FOR EACH FISCAL YEAR, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$200,000 TO THE FUND.”

On page 4, strike in their entirety lines 4 and 5; in lines 6 and 17, strike “**(2)**” and “**(4)**”, respectively, and substitute “**(1)**” and “**(2)**”, respectively; in line 6, strike “**\$75,000**” and substitute “**\$100,000**”; in line 8, after the semicolon insert “**AND**”; strike in their entirety lines 9 through 16, inclusive; in line 17, strike “**\$50,000**” and substitute

“**\$100,000**”; in lines 22, 24, 26, and 29, in each instance, strike the bracket; and in lines 26 and 29, strike “**(2)**” and “**(3)**”, respectively.

On page 5, in lines 3, 7, 9, 11, and 24, in each instance, strike the bracket; and in lines 3, 7, 9, and 11, strike “**(4)**”, “**(5)**”, “**(6)**”, and “**(7)**”, respectively, and substitute “**(5)**”, “**(6)**”, “**(7)**”, and “**(8)**”, respectively.

On page 6, in line 1, strike the bracket; and in line 2, strike “**(A)(7)**” and substitute “**(A)(8)**”.

On pages 6 and 7, strike in their entirety the lines beginning with line 20 on page 6 through line 16 on page 7, inclusive.
