AMENDMENTS TO SENATE BILL 423  
(First Reading File Bill)

AMENDMENT NO. 1

On page 3, strike in their entirety lines 12 through 25, inclusive.

On page 4, in line 1, strike “(D)” and substitute “(C)”; strike line 3 in its entirety; in lines 4, 5, and 7, strike “(2)”, “(3)”, and “(4)”, respectively, and substitute “(1)”, “(2)”, and “(3)”, respectively; after line 7, insert:

“(D) (1) “MEDICAL RESEARCH” MEANS RESEARCH RELATED TO:

(I) THE CAUSES, DIAGNOSIS, TREATMENT, CONTROL, OR PREVENTION OF PHYSICAL OR MENTAL DISEASES OR IMPAIRMENT IN HUMANS OR ANIMALS; OR

(II) THE DEVELOPMENT OF BIOMEDICAL PRODUCTS, MEDICAL DEVICES, OR DRUGS AS DEFINED IN 21 U.S.C. § 321(G).

(2) “MEDICAL RESEARCH” DOES NOT INCLUDE THE TESTING OF AN INGREDIENT THAT WAS FORMERLY USED AS A DRUG AND THAT IS NOW PROPOSED FOR USE IN A PRODUCT OTHER THAN A BIOMEDICAL PRODUCT, MEDICAL DEVICE, OR DRUG.”;

strike in their entirety lines 20 through 21, inclusive; and in lines 22 and 23, strike “(V)” and “(VI)”, respectively, and substitute “(III)” and “(IV)”, respectively.

On page 5, strike beginning with “A DRUG” in line 9 down through “VACCINE,” in line 10; in line 12, strike “DRUG, VACCINE,”; and in line 28, strike “BIOMEDICAL” and substitute “MEDICAL”.

AMENDMENT NO. 2

On page 5, strike beginning with “BY” in line 22 down through “ADMINISTERED” in line 23 and substitute “IN ACCORDANCE WITH THE MOST CURRENT AMERICAN VETERINARY MEDICAL ASSOCIATION GUIDELINES FOR THE EUTHANASIA OF ANIMALS”; in line 25, after “DIRECT” insert “OR INDIRECT”; in the same line, after “A” insert “LICENSED”; and strike beginning with “LICENSED” in line 25 down through “STATE” in line 26.

AMENDMENT NO. 3

On page 8, in lines 2 and 17, in each instance, strike “JANUARY 31” and substitute “DECEMBER 1”; in lines 4 and 19, in each instance, strike “12-MONTH”; in lines 5 and 19, in each instance, strike “PERIOD” and substitute “FISCAL YEAR”; in line 18, after “FACILITY” insert “USING OR KEEPING DOGS OR CATS”; in line 25, after “SECTION” insert “IN AN ANONYMIZED MANNER”; and after line 26, insert:

**“(D) A REPORT MADE TO THE SECRETARY UNDER THIS SECTION IS NOT SUBJECT TO DISCLOSURE UNDER THE MARYLAND PUBLIC INFORMATION ACT.”.**
