AMENDMENT TO SENATE BILL 4
(First Reading File Bill)

On page 6, in line 6, after “(B)” insert “(1)”; in the same line, strike “THIS” and substitute “EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THIS”; in lines 7, 9, and 11, strike “(1)”, “(2)”, and “(3)”, respectively, and substitute “(I)”, “(II)” and “(III)”, respectively; in lines 11 and 13, strike “(I)” and “(II)”, respectively, and substitute “1.” and “2.”, respectively; and after line 14, insert:

“(2) NOTWITHSTANDING SUBSECTION (C)(2) OF THIS SECTION, THIS SECTION DOES NOT APPLY TO A RELIGIOUS ORGANIZATION THAT IS AUTHORIZED TO RECEIVE DEDUCTIBLE DONATIONS THAT ARE SUBJECT TO THE AGGREGATE CONTRIBUTION LIMITATION UNDER § 170(B)(1)(A)(I) OF THE INTERNAL REVENUE CODE.”.

On page 10, in line 11, after “INCLUDE” insert “, UNLESS PERFORMED BY A RELIGIOUS ORGANIZATION THAT IS AUTHORIZED TO RECEIVE DEDUCTIBLE DONATIONS THAT ARE SUBJECT TO THE AGGREGATE CONTRIBUTION LIMITATION UNDER § 170(B)(1)(A)(I) OF THE INTERNAL REVENUE CODE,”.
