AMENDMENTS TO SENATE BILL 774  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 7, in each instance, strike “a”; in lines 7 and 8, in each instance, strike “template” and substitute “templates”; strike beginning with the first “and” in line 9 down through “Act” in line 11; and in line 15, strike “15–2208” and substitute “15–2205”.

AMENDMENT NO. 2

On page 2, in line 16, strike “**MEDICAL OR SURGICAL**” and substitute “**MEDICAL/SURGICAL**”; strike beginning with “**MEANS**” in line 16 down through “**SERVICES**” in line 18 and substitute “**HAS THE MEANING STATED IN § 15–144 OF THIS TITLE**”; in line 19, strike the first “**SERVICES**” and substitute “**BENEFITS**”; strike beginning with “**MEANS**” in line 19 down through “**DISORDERS**” in line 24 and substitute “**HAS THE MEANING STATED IN § 15–144 OF THIS TITLE**”; and strike in their entirety lines 25 and 26 and substitute:

“(H) **“PRODUCT” HAS THE MEANING STATED IN § 15–144 OF THIS TITLE.**”.

On page 3, strike in their entirety lines 12 through 16, inclusive, and substitute:

“(J) **“SUBSTANCE USE DISORDER BENEFITS” HAS THE MEANING STATED IN § 15–144 OF THIS TITLE.**”;

strike beginning with “**MEANS**” in line 17 down through “**ENROLLEES**” in line 20 and substitute “**HAS THE MEANING STATED IN § 15–10B–01 OF THIS TITLE**”; in line 22,

strike “2028” and substitute “2027”; and in line 26, strike “TEMPLATE” and substitute “TEMPLATES”.

On pages 3 and 4, strike beginning with the colon in line 27 on page 3 down through “SUFFICIENT” in line 16 on page 4 and substitute “ALL METRICS THE COMMISSIONER DETERMINES ARE NECESSARY”.

On page 4, in lines 17, 20, 23, and 26, strike “1.”, “2.”, “3.”, and “4.”, respectively, and substitute “(I)”, “(II)”, “(III)”, and “(IV)”, respectively; in line 22, after “PROVIDERS” insert “FOR PROVIDER SPECIALTY TYPES IDENTIFIED BY THE COMMISSIONER”; strike beginning with “NETWORK” in line 23 down through “NETWORKS” in line 25 and substitute “PROVIDER CREDENTIALING AND CONTRACTING TIMELINES BY PROVIDER SPECIALTY TYPE, AS DEFINED BY THE COMMISSIONER”.

On page 5, in lines 1, 4, and 8, strike “5.”, “6.”, and “7.”, respectively, and substitute “(V)”, “(VI)”, and “(VII)”, respectively; after line 21, insert:

**“(C) THE DATA REQUIRED TO BE REPORTED UNDER SUBSECTION (A)(1) SHALL BE DISAGGREGATED BY FACILITY TYPE, PROVIDER TYPE, YOUTH ENROLLEES, AND ADULT ENROLLEES, AS DEFINED BY THE COMMISSIONER.”;**

in line 23, strike the second “A”; in the same line, strike “TEMPLATE” and substitute “TEMPLATES”; and in line 26, strike the first “THE” and substitute “A”.

On page 6, in line 14, strike “3” and substitute “5”; strike beginning with the colon in line 16 down through “(2)” in line 23; and strike beginning with “THAT” in line 24 down through “COMPARISON” in line 26.

On pages 6 and 7, strike beginning with “**15-2205.**” in line 27 on page 6 down through “**15-2208.**” in line 16 on page 7 and substitute “**15-2205.**”.
