AMENDMENTS TO SENATE BILL 984
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Immigration**”; in line 5, strike “or” and substitute “a”; in the same line, after “structure” insert “, or other real property for use”; in line 5, strike “an immigration” and substitute “a”; in line 6, strike “unless certain zoning authority applies”; and in line 8, strike “immigration”.

AMENDMENT NO. 2

On page 2, after line 4, insert:

“(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) (I) “DETENTION FACILITY” MEANS ANY BUILDING, FACILITY, OR STRUCTURE USED, IN WHOLE OR IN PART, TO HOUSE OR DETAIN INDIVIDUALS FOR CIVIL OR CRIMINAL VIOLATIONS.

(II) “DETENTION FACILITY” INCLUDES AN IMMIGRATION DETENTION FACILITY.

(3) “UNIT OF LOCAL GOVERNMENT” MEANS A COUNTY, A MUNICIPALITY, OR THE MARYLAND NATIONAL CAPITAL PARK AND PLANNING COMMISSION.”;

in line 5, strike “(A)” and substitute “(B)”; in the same line, strike “(1)”; in line 6, strike “USE” and substitute “CONSTRUCTION OR OPERATION”; in the same line, strike the second “OR” and substitute “, A”; in lines 7, 15, and 18, in each instance, after

“STRUCTURE” insert “, OR OTHER REAL PROPERTY”; in line 7, strike “AS AN IMMIGRATION” and substitute “FOR A”; strike beginning with “UNLESS” in line 8 down through “AUTHORITY” in line 9; strike in their entirety lines 10 through 13, inclusive; in line 14, strike “(B)” and substitute “(C)”; in the same line, strike the second “OR” and substitute “, A”; in lines 15 and 19, in each instance, strike “AN IMMIGRATION” and substitute “A”; strike beginning with “WITHOUT” in line 15 down through “SECTION” in line 17; in line 18, strike “(C)” and substitute “(D)”; in the same line, strike “OR” and substitute “, A”; and in line 31, strike “(D)” and substitute “(E)”.

On page 3, in line 4, strike “(E)” and substitute “(F)”; strike beginning with “AN” in line 4 down through “IMMIGRATION” in line 5 and substitute “A”; in line 8, strike “(F)” and substitute “(G)”; in line 13, in each instance, strike “or structure” and substitute “, structure, or other real property”; in the same line, strike “an immigration” and substitute “a”; in line 15, strike the second “or” and substitute a comma; and in the same line, after “structure” insert “, or other real property”.
