AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate Metzgar**” and substitute “**Delegates Metzgar, Crutchfield, Fair, Kerr, Lehman, Ruth, Sample-Hughes, Schmidt, Solomon, Terrasa, Wells, Wilson, Wu**”; in line 2, strike “**Public Health**” and substitute “**State Government**”; and strike in their entirety lines 7 through 12, inclusive, and substitute:

AMENDMENT NO. 2

On page 1, in line 15, strike “**Health – General**” and substitute “**State Government**”; in line 16, strike “**28.**” and substitute “**42.**”; in lines 17 and 20, strike “**24–2801.**” and “**24–2802.**”, respectively, and substitute “**9–4201.**” and “**9–4202.**”, respectively.

On page 2, in lines 2, 4, 18, 20, and 22, in each instance, strike “**ONE**” and substitute “**ONE**”; in lines 6, 7, 9, and 13, in each instance, strike “**THE**” and substitute “**THE**”; in line 6, strike “**HEALTH**” and substitute “**SOCIAL AND ECONOMIC MOBILITY**”; in line 10, after “**DESIGNEE;**” insert “**AND**”; strike beginning with “**THE**” in line 11 down through “**(7)**” in line 13; strike beginning with “**ONE**” in line 14 down through “**(III)**” in line 18; in lines 20 and 22, strike “**(IV)**” and “**(V)**”, respectively, and

substitute “**(II)**” and “**(III)**”, respectively; and in line 24, strike “**GOVERNOR**” and substitute “**SECRETARY OF SOCIAL AND ECONOMIC MOBILITY**”.

On page 3, in line 2, strike “**MAY**” and substitute “**MAY**”; in line 4, strike “**IS**” and substitute “**IS**”; strike beginning with “**IN**” in line 7 down through “**PROMOTE**” in line 11 and substitute “**PROMOTE**”; in lines 13, 15, 17, and 19, strike “**(3)**”, “**(4)**”, “**(5)**”, and “**(6)**”, respectively, and substitute “**(2)**”, “**(3)**”, “**(4)**”, and “**(5)**”, respectively; in line 13, strike “**CURATE**” and substitute “**CURATE**”; in line 15, strike “**WORK**” and substitute “**WORK**”; in line 17, strike “**PROMOTE**” and substitute “**PROMOTE**”; in line 19, strike “**MAKE**” and substitute “**MAKE**”; and in line 23, strike “**THE STATE GOVERNMENT ARTICLE**” and substitute “**THIS ARTICLE**”.
