AMENDMENTS TO HOUSE BILL 1166  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 4, after “have” insert “a certain”; in lines 5 and 8, in each instance, strike “mounting hardware” and substitute “display mechanism”; in line 6, strike “mounting hardware” and substitute “display mechanism”; in line 7, strike “report” and substitute “submit”; in the same line, after “of” insert “a certain”; in line 8, strike “on” and substitute “in”; and in line 9, strike “periodic basis” and substitute “manner; requiring the Administration to develop a certain disclosure statement”.

AMENDMENT NO. 2

On page 4, in line 4, strike the first comma and substitute “**OR**”; in the same line, strike “**, OR EXCHANGE**”; in the same line, after the last “**A**” insert “**NEW**”; in the same line, after “**VEHICLE**” insert “**THAT WILL BE REGISTERED IN THE STATE AND**”; in line 9, after “**HARDWARE**” insert “**OR ANOTHER MECHANISM**”; in line 10, after “**VEHICLE**” insert “**IN ACCORDANCE WITH § 13-411 OF THIS ARTICLE**”; in lines 14 and 19, in each instance, after “**HARDWARE**” insert “**OR ANOTHER PLATE DISPLAY MECHANISM**”; in line 24, strike “**ON A MONTHLY BASIS, A**” and substitute “**A**”; in the same line, strike “**REPORT**” and substitute “**SUBMIT EACH WRITTEN STATEMENT SIGNED UNDER SUBSECTION (A)(2) OF THIS SECTION**”; strike beginning with “**THE**” in line 25 down through “**SECTION**” in line 26 and substitute “**TOGETHER WITH THE DOCUMENTS REQUIRED UNDER § 13-113 OF THIS ARTICLE FOR REGISTRATION OF THE VEHICLE THAT IS THE SUBJECT OF THE STATEMENT**”; and after line 26, insert:

**“(C) A DEALER WHO SUBMITS A SIGNED WRITTEN STATEMENT UNDER SUBSECTION (B) OF THIS SECTION MAY NOT BE HELD LIABLE UNDER § 26-101 OF**

THIS ARTICLE WITH RESPECT TO THE BUYER OR LESSEE WHO SIGNED THE STATEMENT.

(D) THE ADMINISTRATION SHALL:

(1) DEVELOP A WRITTEN STATEMENT FOR USE BY DEALERS UNDER SUBSECTION (A)(2) OF THIS SECTION; AND

(2) ADOPT REGULATIONS TO IMPLEMENT THIS SECTION, INCLUDING PROCEDURES GOVERNING:

(i) THE SUBMISSION OF WRITTEN STATEMENTS UNDER SUBSECTION (B) OF THIS SECTION; AND

(ii) THE USE AND DISCLOSURE OF INFORMATION CONTAINED IN A WRITTEN STATEMENT, INCLUDING DISCLOSURE TO LAW ENFORCEMENT FOR ENFORCEMENT OF § 13-411 OF THIS ARTICLE.”.
