AMENDMENTS TO HOUSE BILL 107  
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, strike “authorizing” and substitute “requiring”.

AMENDMENT NO. 2

On page 2, strike beginning with “ELECTS” in line 26 down through “PARTICIPATE” in line 27 and substitute “PARTICIPATES”.

On page 3, in lines 7, 10, 24, and 30, in each instance, strike “CALIBRATE,” and substitute “TUNE,”; in line 12, after “**(3)**” insert ““INTELLIGENT SPEED ASSISTANCE SYSTEM” MEANS AN AFTERMARKET DEVICE THAT DETERMINES THE APPLICABLE SPEED LIMIT AND ACTIVELY PREVENTS A MOTOR VEHICLE FROM EXCEEDING THE APPLICABLE SPEED LIMIT.”

**(4)**”;

and in lines 14 and 16, strike “**(4)**” and “**(5)**”, respectively, and substitute “**(5)**” and “**(6)**”, respectively.

On page 4, in line 5, strike “CALIBRATE,” and substitute “TUNE,”.

On pages 4 and 5, strike beginning with the colon in line 27 on page 4 down through “YEAR” in line 4 on page 5 and substitute “1 YEAR”.

On page 6, after line 20, insert:

“(J) (1) SUBJECT TO PARAGRAPHS (3) AND (4) OF THIS SUBSECTION, THE ADMINISTRATION OR A VENDOR CONTRACTED BY THE ADMINISTRATION MAY SHARE DATA COLLECTED UNDER THIS SECTION ONLY:

(I) WHEN REQUIRED BY COURT ORDER;

(II) AS REQUIRED BY STATE LAW;

(III) WITH THE DEPARTMENT OR A COURT WITH JURISDICTION OVER A PROGRAM PARTICIPANT REGARDING A VIOLATION BY THE PARTICIPANT; OR

(IV) FOR RESEARCH PURPOSES, IF THE DATA IS ANONYMIZED.

(2) SUBJECT TO PARAGRAPHS (3) AND (4) OF THIS SUBSECTION, THE ADMINISTRATION OR A VENDOR CONTRACTED BY THE ADMINISTRATION MAY RETAIN DATA COLLECTED UNDER THIS SECTION ONLY TO:

(I) CONFIRM COMPLIANCE WITH PROGRAM REQUIREMENTS; OR

(II) EVALUATE OR IMPROVE THE EFFECTIVENESS OF THE PROGRAM.

(3) THE ADMINISTRATION OR ANY VENDOR CONTRACTED BY THE ADMINISTRATION SHALL REMOVE FROM ITS RECORDS AND DESTROY ANY DATA COLLECTED UNDER THIS SECTION WITHIN 90 DAYS AFTER COLLECTING THE DATA.

**(4) DATA COLLECTED UNDER THIS SECTION MAY NOT BE SOLD FOR ANY PURPOSE BY THE ADMINISTRATION OR A VENDOR CONTRACTED BY THE ADMINISTRATION, INCLUDING THE SALE OF SUBSCRIPTIONS OR LICENSES TO ACCESS DATA.**”;

and in line 21, strike “**(J)**” and substitute “**(K)**”.
