AMENDMENTS TO SENATE BILL 187
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike "**Reentry**" and substitute "**Prerelease**"; after line 3, insert:

"(Monica Cooper Prerelease Act)";

strike beginning with "altering" in line 4 down through "facility;" in line 5; strike beginning with "direct" in line 7 down through "individuals" in line 9 and substitute "submit a certain timeline of deliverables to certain entities"; strike beginning with "implement" in line 12 down through "date" in line 13 and substitute "meet certain requirements relating to the planning, construction, and operation of the prerelease facility"; in lines 6 and 20, in each instance, strike "reentry" and substitute "prerelease"; strike beginning with "requiring" in line 13 down through "Assembly;" in line 15; and in line 16, after "committees;" insert "requiring the Department of General Services to provide an update on the progress of design and construction of the prerelease facility to certain legislative committees;".

AMENDMENT NO. 2

On page 2, in line 17, strike "**(A)**"; in the same line, strike "**(1)**"; strike beginning with "**THE**" in line 17 down through "**ELIGIBLE**" in line 19 and substitute "**, ELIGIBLE**"; in line 19, strike "**A**" and substitute "**AN INCARCERATED**"; in lines 20 and 22, strike "**(I)**" and "**(II)**", respectively, and substitute "**(1)**" and "**(2)**", respectively; in line 20, strike "**18**" and substitute "**36**"; in line 22, after "**PRERELEASE**" insert "**OR MINIMUM SECURITY**"; strike in their entirety lines 23 through 25, inclusive; in line 28, after "rehabilitative" insert "prerelease"; in the same line, strike "**REENTRY**"; and in line 31, strike "**3-304(B)**" and substitute "**3-305**".

On page 3, in line 6, strike “**3-304(B)**” and substitute “**3-305**”; and in line 21, strike “**A CLASSROOM**” and substitute “**CLASSROOMS**”.

On page 4, in line 4, after “A” insert “**prerelease**”; in lines 4, 20, and 25, in each instance, strike “**REENTRY**”; strike beginning with “**THE**” in line 6 down through “**AND**” in line 9 and substitute “**BALTIMORE CITY ON A SITE THAT IS:**

(I) NOT LESS THAN 3 ACRES IN LAND AREA; AND

**(II) NOT LOCATED WITHIN ONE-HALF MILE OF ANY EXISTING
CORRECTIONAL FACILITY; AND**”;

in line 17, strike “**2024,**” and substitute “**2023,**”; in line 20, after “a” insert “**prerelease**”; in line 22, strike “**3-306(A)**” and substitute “**3-307(A)**”; in line 24, after “the” insert “**prerelease**”; in line 25, strike “June 1, 2021” and substitute “**OCTOBER 1, 2027, OR NOT LATER THAN 6 MONTHS THEREAFTER**”; in lines 26 and 27, strike “September 1, 2021; and” and substitute “**JULY 1, 2028, OR NOT LATER THAN 6 MONTHS THEREAFTER;**”; in line 28, after “(3)” insert “**COMPLETE THE CONSTRUCTION OR RENOVATION ON OR BEFORE MARCH 1, 2031, OR NOT LATER THAN 6 MONTHS THEREAFTER; AND**

(4)”;

and in lines 28 and 29, strike “June 1, 2023” and substitute “**SEPTEMBER 1, 2031, OR NOT LATER THAN 6 MONTHS THEREAFTER**”.

On pages 4 and 5, strike beginning with the colon in line 32 on page 4 down through “**SECTION,**” in line 13 on page 5.

On page 5, in line 14, strike “**REENTRY**” and substitute “**PRERELEASE**”.

On page 6, in line 11, after “a” insert “prerelease”; and in lines 11 and 12, strike “[prerelease unit] REENTRY”.

On page 7, in line 1, strike “(1)”; in the same line, after “evidence-based” insert “, TRAUMA-INFORMED,”; in line 2, strike the bracket; in the same line, strike “unit” and substitute “FACILITY”; in line 3, strike “3-301” and substitute “3-302”; in the same line, strike the bracket; strike in their entirety lines 4 through 6, inclusive; in line 8, after “evidence-based” insert “, TRAUMA-INFORMED, AND GENDER-RESPONSIVE”; in line 18, strike the second “and”; in line 22, after “needs” insert “; AND”

(5) SCREEN FEMALE INCARCERATED INDIVIDUALS FOR ELIGIBILITY FOR PUBLIC BENEFITS AND PROVIDE RELEVANT APPLICATIONS AND ASSISTANCE COMPLETING EACH APPLICATION PRIOR TO RELEASE AS PART OF A REENTRY PLAN”;

in line 7, after “rehabilitative” insert “prerelease”; in the same line, strike “REENTRY”; strike beginning with “(1)” in line 23 down through “(E)” in line 29; and in line 31, strike “REENTRY” and substitute “PRERELEASE”.

On page 8, in lines 1, 2, 3, and 4, in each instance, strike the brackets; in lines 3 and 6, in each instance, strike “unit” and substitute “FACILITY”; in line 3, strike “REENTRY”; strike in their entirety lines 7 and 8; in lines 11 and 20, in each instance, after “a” insert “prerelease”; and in the same lines, in each instance, strike “[prerelease unit] REENTRY”.

On pages 8 and 9, strike in their entirety the lines beginning with line 28 on page 8 through line 12 on page 9, inclusive.

On page 9, in line 13, strike “3.” and substitute “2.”; in lines 13 and 14, strike “June 1, 2026,” and substitute “December 15, 2026,”; in line 20, strike “4.” and substitute

“3.”; in line 21, strike “July 1, 2026,” and substitute “May 1, 2027,”; in line 23, strike “reentry” and substitute “prerelease”; in line 27, strike “5.” and substitute “4.”; and in line 28, strike “Beginning June 1, 2026” and substitute “On or before June 1 each year beginning June 1, 2027”.

On page 10, in line 4, strike “6.” and substitute “5.”.
