AMENDMENTS TO SENATE BILL 197
(First Reading File Bill)

AMENDMENT NO. 1

On page 6, strike line 29 in its entirety; and in line 30, strike “**(II)**” and substitute “**(I)**”.

On page 7, strike line 1 in its entirety; and in lines 2, 3, 4, 5, 6, 7, 8, 9, and 10, strike “**(IV)**”, “**(V)**”, “**(VI)**”, “**(VII)**”, “**(VIII)**”, “**(IX)**”, “**(X)**”, “**(XI)**”, and “**(XII)**”, respectively, and substitute “**(II)**”, “**(III)**”, “**(IV)**”, “**(V)**”, “**(VI)**”, “**(VII)**”, “**(VIII)**”, “**(IX)**”, and “**(X)**”, respectively.

On page 20, in line 3, strike “**PLAN, DESIGN, AND PROGRAM**” and substitute “**PLAN**”.

On page 23, in line 23, strike “**USE**”.

On page 30, strike line 10 in its entirety; strike line 12 in its entirety; and in lines 11, 13, 14, 15, 16, 17, 18, 19, 20, and 21, strike “**(II)**”, “**(IV)**”, “**(V)**”, “**(VI)**”, “**(VII)**”, “**(VIII)**”, “**(IX)**”, “**(X)**”, “**(XI)**”, and “**(XII)**”, respectively, and substitute “**(I)**”, “**(II)**”, “**(III)**”, “**(IV)**”, “**(V)**”, “**(VI)**”, “**(VII)**”, “**(VIII)**”, “**(IX)**”, and “**(X)**”, respectively.

On page 44, in line 9, strike “**PLAN, DESIGN, AND PROGRAM**” and substitute “**PLAN**”.

AMENDMENT NO. 2

On page 37, strike beginning with “**MARYLAND**” in line 7 down through “**PLAN**” in line 8 and substitute “**FOLLOWING STATE PLANS:**”

(I) THE FAIR HOUSING CHOICE AND RACIAL AND ECONOMIC HOUSING INTEGRATION REPORT, AS DESCRIBED IN § 2-302 OF THE HOUSING AND COMMUNITY DEVELOPMENT ARTICLE; AND

(II) THE STATE OF MARYLAND FIVE YEAR CONSOLIDATED PLAN, AS REQUIRED BY 24 C.F.R. § 91.300”.

On page 52, after line 11, insert:

“SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to a county or municipal corporation that amends, revises, readopts, or modifies a comprehensive plan, or that begins the process of amending, revising, readopting, or modifying a comprehensive plan, before the effective date of this Act.”;

and in line 12, strike “4.” and substitute “5.”.
