AMENDMENTS TO HOUSE BILL 108

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate**” and substitute “**Delegates**”; in the same line, after “**Pasteur**” insert “**, Crutchfield, Fair, Lehman, Ruth, Sample–Hughes, Schindler, Schmidt, Solomon, Terrasa, Wells, and Wu**”; in line 2, strike “**Release Preparation**” and substitute “**Volunteer Services**”; in line 3, strike “Release Preparation” and substitute “**Volunteer Services**”; in line 4, after “to” insert “**volunteers, including**”; in the same line, after “individuals” insert “**and organizations led by formerly incarcerated individuals,**”; strike beginning with “altering” in line 6 down through the semicolon in line 8; in line 8, strike “Release Preparation” and substitute “**Volunteer Services**”; and strike in their entirety lines 9 through 13, inclusive.

AMENDMENT NO. 2

On pages 1 through 3, strike in their entirety the lines beginning with line 21 on page 1 through line 9 on page 3, inclusive.

AMENDMENT NO. 3

On page 3, in lines 12 and 14, in each instance, strike “**RELEASE PREPARATION**” and substitute “**VOLUNTEER SERVICES**”; in line 16, strike “**(1)**”; in line 17, after “**REGISTERING**” insert “**VOLUNTEERS, INCLUDING**”; in the same line, after “**INDIVIDUALS**” insert “**AND ORGANIZATIONS LED BY FORMERLY INCARCERATED INDIVIDUALS,**”; strike in their entirety lines 20 through 22, inclusive; in line 25, after “**(1)**” insert “**THE DIVISION OF CORRECTION TO MAINTAIN A RECORD OF VOLUNTEERS REGISTERED IN THE PROGRAM;**

(2) SUBJECT TO SUBSECTION (E) OF THIS SECTION,”;

in the same line, strike “**FORMERLY INCARCERATED INDIVIDUALS**” and substitute “**VOLUNTEERS**”; in line 27, strike “**(2)**” and substitute “**(3)**”; in the same line, strike “**FORMERLY INCARCERATED INDIVIDUAL**” and substitute “**VOLUNTEER**”; in line 29, strike “**INDIVIDUAL**” and substitute “**VOLUNTEER**”; after line 29, insert:

“(E) A VOLUNTEER IN THE PROGRAM:

(1) HAS THE RIGHT TO ELECT WHETHER THE VOLUNTEER’S NAME IS MADE AVAILABLE TO THE PUBLIC; AND

(2) MUST CONSENT IN WRITING IF THE VOLUNTEER ELECTS THE DISCLOSURE OF THE VOLUNTEER’S NAME TO THE PUBLIC.”;

and in line 30, strike “**(E)**” and substitute “**(F)**”.

On page 4, in line 1, strike “**(D)(2)**” and substitute “**(D)(3)**”.
