**AMENDMENTS TO HOUSE BILL 488**  
(First Reading File Bill)

**AMENDMENT NO. 1**

On page 1, after line 22, insert:

“Preamble

WHEREAS, The decennial census, mandated under Article I, § 2 of the U.S. Constitution, informs the reapportionment and redistricting process, with the last census occurring in 2020; and

WHEREAS, Each state is allowed to adopt a congressional redistricting process that applies to its particular needs; and

WHEREAS, Free and fair elections are the right of every citizen in the United States; and

WHEREAS, In 2021, Governor Hogan established the Maryland Citizens Redistricting Commission, a balanced citizens' commission consisting of equal numbers of nonlegislator Democrats, Republicans, and Independents, for the purpose of creating a congressional districting plan that is free from political influence and, to the extent practical, respects natural boundaries and boundaries of political subdivisions and provides communities with a voice, while respecting the principle of “one person, one vote”; and

WHEREAS, The congressional redistricting plan prepared by the Maryland Citizens Redistricting Commission will enable a larger number of Marylanders to fully participate in the choosing of their representatives; now, therefore, ”.

**AMENDMENT NO. 2**

On page 2, strike in their entirety lines 5 through 16, inclusive, and substitute:

“(b) (1) The descriptions of congressional districts in this section include the references indicated.

(2) (i) The references to:

1. election districts and wards are to the geographical boundaries of the election districts and wards as they existed on April 1, 2020; and

2. precincts are to the geographical boundaries of the precincts as reviewed and certified by the local boards or their designees, before they were reported to the U.S. Bureau of the Census as part of the 2020 census redistricting data program and as those precinct lines are specifically indicated in the P.L. 94-171 data or shown on the P.L. 94-171 census block maps provided by the U.S. Bureau of the Census and as reviewed and corrected by the Maryland Department of Planning.

(ii) Where precincts are split between congressional districts, census tract and block numbers, as indicated in P.L. 94-171 data or shown on the P.L. 94-171 census block maps provided by the U.S. Bureau of the Census and referred to in this subtitle, are used to define the boundaries of congressional districts.”.

On pages 2 through 18, strike in their entirety the lines beginning with line 17 on page 2 through line 17 on page 18, inclusive, and substitute:
