AMENDMENTS TO HOUSE BILL 1048  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**and Cullison**” and substitute “**Cullison, Alston, Bagnall, Guzzone, Kaufman, Lopez, Martinez, Rosenberg, Ross, White Holland, and Woorman**”; in line 2, after “**Icons**” insert “**and Disclosure and Notice**”; strike beginning with “administer” in line 5 down through “time” in line 6 and substitute “**direct chain restaurants to its website for a certain purpose**”; in line 8, after the second “content” insert “**and a certain disclosure and notice**”; and in line 9, strike “high sodium and added sugars menu icons” and substitute “**menu items with high sodium and added sugars**”.

AMENDMENT NO. 2

On page 3, in line 18, strike “**IS**” and substitute “**:**”

**(I) IS**”;

in line 21, after “**ITEMS**” insert “**; AND**”

**(II) IS SUBJECT TO FEDERAL LABELING REQUIREMENTS UNDER 21 U.S.C. § 343(Q)(5)(H)**”;

and in line 22, strike “**MILLIGRAMS**” and substitute “**GRAMS**”.

On page 4, strike beginning with “**ADMINISTER**” in line 19 down through “**EXPLAINS**” in line 20 and substitute “**DIRECT CHAIN RESTAURANTS TO ITS WEBSITE FOR THE PURPOSE OF EXPLAINING**”; in line 22, strike “**2028**” and substitute “**2027**”; in line 27, strike “**AND**”; in line 31, after “**SECTION**” insert “**; AND**”

**(3) A WRITTEN DISCLOSURE AND NOTICE TO CUSTOMERS THAT:**

**(I) STANDARD MENU ITEMS MAY CONTAIN HIGH SODIUM OR HIGH SUGAR; AND**

**(II) FULL NUTRITIONAL INFORMATION IS AVAILABLE THROUGH A QUICK RESPONSE (QR) CODE, ONLINE, OR BY REQUEST.**

**(F) A CHAIN RESTAURANT MAY COMPLY WITH SUBSECTION (E)(3) OF THIS SECTION BY MAKING THE FULL NUTRITIONAL INFORMATION OF THE FOOD OR BEVERAGE ITEM AVAILABLE:**

**(1) THROUGH USE OF A QUICK RESPONSE (QR) CODE THAT LINKS TO THE CHAIN RESTAURANT'S ONLINE NUTRITIONAL INFORMATION; AND**

**(2) ON REQUEST OF A CUSTOMER, IN ANY PRINTED FORMAT".**

On page 5, in line 1, strike "(F)" and substitute "(G)"; strike in their entirety lines 18 through 27, inclusive; and in line 29, strike "paragraph (2)" and substitute "PARAGRAPHS (2) AND (3)".

On page 6, in line 3, strike "OR § 21-330.3"; and after line 4, insert:

**"(3) A PERSON WHO VIOLATES § 21-330.3 OF THIS TITLE IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO:**

**(I) FOR A FIRST OFFENSE, A FINE NOT EXCEEDING \$500; AND**

(II) FOR A SUBSEQUENT OFFENSE, A FINE NOT EXCEEDING  
\$1,000.".
