AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**and Hornberger**” and substitute “ **Hornberger, Lehman, Ruth, Schindler, Terrasa, Wells, and Wu**”; in line 6, strike “Secretary of Labor” and substitute “Public Employee Relations Board”; in line 7, strike “Secretary” and substitute “Board”; and after line 22, insert:

“BY repealing and reenacting, with amendments,

Article - State Government

Section 22-306(a)

Annotated Code of Maryland

(2021 Replacement Volume and 2025 Supplement)”.

AMENDMENT NO. 2

On page 2, in line 5, after “**(B)**” insert ““**BOARD**” MEANS THE PUBLIC EMPLOYEE RELATIONS BOARD.

(C)”;

in line 9, strike “**(C)**” and substitute “**(D)** **(1)**”; in the same line, after “**INDIVIDUAL**” insert “;

(I)”;

in line 11, after “**OPERATION**” insert “; **AND**

(II) WHOSE JOB DUTIES REQUIRE WORKING IN A GREENHOUSE OR OTHER ENCLOSED STRUCTURE WHERE TEMPERATURE AND ENVIRONMENTAL CONDITIONS ARE ARTIFICIALLY REGULATED.

(2) “EMPLOYEE” DOES NOT INCLUDE AN INDIVIDUAL WHOSE JOB DUTIES EXCLUSIVELY INVOLVE THE PROVISION OF RETAIL SERVICES”;

in lines 12, 15, and 19, strike “(D)”, “(E)”, and “(F)”, respectively, and substitute “(E)”, “(F)”, and “(G)”, respectively; and strike line 24 in its entirety.

On page 3 in lines 11 and 24, and on page 4 in lines 6 and 15, in each instance, strike “SECRETARY” and substitute “BOARD”.

On page 5, in line 14, after “EMPLOYEE” insert “:

(1)”;

in line 15, after “OPERATION” insert “;AND

(2) WHOSE JOB DUTIES REQUIRE WORKING IN A GREENHOUSE OR OTHER ENCLOSED STRUCTURE WHERE TEMPERATURE AND ENVIRONMENTAL CONDITIONS ARE ARTIFICIALLY REGULATED”;

and after line 29, insert:

“Article – State Government
