AMENDMENTS TO HOUSE BILL 639

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate Charkoudian**” and substitute “**Delegates Charkoudian, Allen, Behler, Foley, Lewis, and Stein**”; strike beginning with the second “the” in line 4 down through “requiring” in line 6; strike beginning with “to” in line 7 down through “aircraft” in line 8 and substitute “that service a flight with detained individuals to request to see a warrant for the detained individual, and to note whether there is a warrant and the type of warrant”; in line 9, strike “compile, and a member of each flight crew to sign,” and substitute “compile”; strike beginning with “prohibiting” in line 10 down through “services;” in line 14; and in line 23, strike “5–107, 5–108, and 5–1010” and substitute “5–107”.

AMENDMENT NO. 2

On page 2, strike beginning with “**AERONAUTICAL**” in line 14 down through “**(3)**” in line 20; in lines 22 and 24, strike “**(4)**” and “**(5)**”, respectively, and substitute “**(3) (1)**” and “**(4)**”, respectively; and after line 23, insert:

“(II) “DETAINED INDIVIDUAL” DOES NOT INCLUDE:

1. A PASSENGER WHO IS USING A SEAT BELT THAT IS STANDARD EQUIPMENT ON THE AIRCRAFT; OR

2. A CHILD PASSENGER IN A CHILD SAFETY SEAT.”

On pages 3 and 4, strike in their entirety the lines beginning with line 1 on page 3 through line 9 on page 4, inclusive, and substitute:

“(B) IF AN FBO OR AVIATION SERVICE COMPANY SERVICES A FLIGHT WITH A DETAINED INDIVIDUAL ON BOARD, THE FBO OR AVIATION SERVICE COMPANY SHALL:

(1) REQUEST TO SEE THE WARRANT THAT AUTHORIZES THE TRANSPORT OF THE DETAINED INDIVIDUAL; AND

(2) NOTE WHETHER THERE IS A WARRANT, AND WHETHER THE WARRANT IS A JUDICIAL WARRANT OR AN ADMINISTRATIVE WARRANT.”.

On page 4, in line 10, strike “(G)” and substitute “(C)”; in the same line, strike “(1)”; in line 11, strike “(I)” and substitute “(1)”; strike beginning with “DOCUMENTS,” in line 11 down through “TITLE;” in line 17 and substitute “DOCUMENTS:”

(I) THE NUMBER OF FLIGHTS:

1. THE FBO OR AVIATION SERVICE COMPANY SERVICED THAT HAD A DETAINED INDIVIDUAL ON BOARD;

2. THAT HAD A JUDICIAL WARRANT FOR ALL DETAINED INDIVIDUALS ON BOARD;

3. THAT HAD A JUDICIAL WARRANT AND AN ADMINISTRATIVE WARRANT FOR DETAINED INDIVIDUALS ON BOARD;

4. THAT HAD DETAINED INDIVIDUALS ON BOARD AND WERE REFUELED WITH DETAINED INDIVIDUALS ON BOARD; AND

**5. WHERE THE DETAINED INDIVIDUALS WERE
REMOVED FROM THE PLANE DURING REFUELING, FOR THE PURPOSE OF
REFUELING SAFETY; AND**

**(II) ANY FLIGHT THAT DOES NOT HAVE A WARRANT FOR
DETAINED INDIVIDUALS ON BOARD;**

and in line 18, strike “(II)” and substitute “**(2)**”.

On pages 4 through 6, strike in their entirety the lines beginning with line 20 on page 4 through line 6 on page 6, inclusive.
