A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicle Administration – Identification Cards – Issuance to Minors**

3 FOR the purpose of prohibiting the Motor Vehicle Administration from requiring a parent
4 or legal guardian of a minor at least a certain age to cosign or be present at the time
5 of submission of the minor's application for an identification card; requiring the
6 Administration to adopt regulations establishing acceptable forms of documentation
7 establishing proof of residency that a minor at least a certain age may use in an
8 application for an identification card; and generally relating to State-issued
9 identification cards for minors.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

16 That the Laws of Maryland read as follows:

17 **Article – Transportation**

18 12-301.

19 (a) (1) On application, the Administration shall issue an identification card to
20 any applicant who:

21 [(1)] (I) Is a resident of this State;

22 [(2)] (II) Does not have a driver's license;

1 **[(3)] (III)** Presents a birth certificate or other proof of age and identity
2 acceptable to the Administration;

3 **[(4)] (IV)** Provides satisfactory documentary evidence that the applicant
4 has lawful status;

5 **[(5) (i)] (V)** 1. Provides satisfactory documentary evidence that
6 the applicant has a valid Social Security number by presenting the applicant's Social
7 Security Administration account card or, if the Social Security Administration account card
8 is not available, any of the following documents bearing the applicant's Social Security
9 number:

10 [1.] A. A current W-2 form;

11 [2.] B. A current SSA-1099 form;

12 [3.] C. A current non-SSA-1099 form; or

13 [4.] D. A current pay stub with the applicant's name and
14 Social Security number on it; or

15 **[(ii)] 2.** Provides satisfactory documentary evidence that the
16 applicant is not eligible for a Social Security number; and

17 **[(6)] (VI)** Presents a completed application for an identification card on a
18 form furnished by the Administration.

19 **(2) THE ADMINISTRATION MAY NOT REQUIRE A PARENT OR LEGAL**
20 **GUARDIAN OF A MINOR AT LEAST 15 YEARS OF AGE TO COSIGN OR BE PRESENT AT**
21 **THE TIME OF SUBMISSION OF THE MINOR'S APPLICATION FOR AN IDENTIFICATION**
22 **CARD.**

23 **(3) (I) THE ADMINISTRATION SHALL ADOPT REGULATIONS**
24 **ESTABLISHING ACCEPTABLE FORMS OF DOCUMENTATION ESTABLISHING PROOF OF**
25 **RESIDENCY THAT A MINOR AT LEAST 15 YEARS OF AGE MAY USE IN AN APPLICATION**
26 **FOR AN IDENTIFICATION CARD, INCLUDING:**

27 **1. SCHOOL ENROLLMENT RECORDS, REPORT CARDS, OR**
28 **TRANSCRIPTS ISSUED BY A PUBLIC OR PRIVATE SCHOOL;**

29 **2. DOCUMENTATION FROM A HOMELESS SERVICES**
30 **PROVIDER, SHELTER, OR SOCIAL SERVICES AGENCY THAT VERIFIES RESIDENCY;**

31 **3. COURT DOCUMENTS;**

1 **4. CHILD WELFARE AGENCY RECORDS;**

2 **5. HEALTH INSURANCE DOCUMENTS;**

3 **6. IF ACCOMPANIED BY SUFFICIENT DOCUMENTATION**
4 **ESTABLISHING PROOF OF THE ADULT'S RESIDENCE, A NOTARIZED AFFIDAVIT**
5 **SIGNED BY AN ADULT WITH WHOM THE MINOR RESIDES ATTESTING TO THE MINOR'S**
6 **RESIDENCY; OR**

7 **7. ANY OTHER DOCUMENT THAT THE ADMINISTRATION**
8 **DETERMINES APPROPRIATE.**

9 **(II) IF A MINOR AT LEAST 15 YEARS OF AGE IS UNABLE TO**
10 **PROVIDE DOCUMENTATION THAT SATISFIES THE REQUIREMENTS OF THE FEDERAL**
11 **REAL ID ACT, THE ADMINISTRATION MAY ISSUE AN IDENTIFICATION CARD THAT**
12 **IS NOT COMPLIANT WITH THE FEDERAL REAL ID ACT.**

13 **(III) THIS PARAGRAPH MAY NOT BE CONSTRUED TO LIMIT THE**
14 **ADMINISTRATION'S AUTHORITY TO REQUIRE DOCUMENTATION NECESSARY TO**
15 **COMPLY WITH THE REQUIREMENTS OF THE FEDERAL REAL ID ACT, INCLUDING**
16 **DOCUMENTATION ESTABLISHING PROOF OF RESIDENCY.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2026.
