A BILL ENTITLED

1 AN ACT concerning

2 **Local Law Enforcement Vehicles – Requirements – Automated External**
3 **Defibrillators**

4 FOR the purpose of requiring local law enforcement vehicles to carry automated external
5 defibrillators; requiring a local law enforcement agency to maintain the functionality
6 of an automated external defibrillator carried by a local law enforcement vehicle; and
7 generally relating to requirements for local law enforcement vehicles.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Public Safety**

16 **3–510.**

17 **(A) IN THIS SECTION, “AUTOMATED EXTERNAL DEFIBRILLATOR” MEANS A**
18 **MEDICAL HEART MONITOR AND DEFIBRILLATOR DEVICE THAT:**

19 **(1) IS CLEARED FOR MARKET BY THE FEDERAL FOOD AND DRUG**
20 **ADMINISTRATION;**

21 **(2) RECOGNIZES THE PRESENCE OR ABSENCE OF VENTRICULAR**
22 **FIBRILLATION OR RAPID VENTRICULAR TACHYCARDIA;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(3) DETERMINES, WITHOUT INTERVENTION BY AN OPERATOR,**
2 **WHETHER DEFIBRILLATION SHOULD BE PERFORMED;**

3 **(4) ON DETERMINING THAT DEFIBRILLATION SHOULD BE**
4 **PERFORMED, AUTOMATICALLY CHARGES; AND**

5 **(5) (I) REQUIRES OPERATOR INTERVENTION TO DELIVER THE**
6 **ELECTRICAL IMPULSE; OR**

7 **(II) AUTOMATICALLY CONTINUES WITH DELIVERY OF THE**
8 **ELECTRICAL IMPULSE.**

9 **(B) EACH LOCAL LAW ENFORCEMENT VEHICLE SHALL CARRY AN**
10 **AUTOMATED EXTERNAL DEFIBRILLATOR.**

11 **(C) A LOCAL LAW ENFORCEMENT AGENCY SHALL MAINTAIN THE**
12 **FUNCTIONALITY OF EACH AUTOMATED EXTERNAL DEFIBRILLATOR DESCRIBED IN**
13 **SUBSECTION (B) OF THIS SECTION.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2026.
