## A BILL ENTITLED

1 AN ACT concerning

2 **Local Government – Regulatory Powers – Regulation of Tree of Heaven**

3 FOR the purpose of authorizing the governing body of a county or municipality to adopt  
4 certain ordinances to regulate trees of heaven; authorizing the governing body of a  
5 county or municipality to establish a bounty program to incentivize the removal of  
6 trees of heaven; and generally relating to local management of trees of heaven.

7 BY repealing and reenacting, with amendments,

### 12 Preamble

13 WHEREAS, Invasive species are nonnative plants and animals whose introduction  
14 causes harm to human health, environmental harm, or economic harm – typically through  
15 unchecked growth; and

16 WHEREAS, The tree of heaven is a nonnative, deciduous hardwood tree that is  
17 considered an invasive species throughout North America because the species spreads  
18 quickly and aggressively, crowding out native plants with dense greenery while secreting  
19 a chemical into the soil that is toxic to surrounding plants; and

20 WHEREAS, The tree of heaven is the preferred habitat for the spotted lanternfly,  
21 another invasive species that is causing economic damage to the agricultural community,  
22 stressing native plant populations, and generally acting as a nuisance statewide; now,

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That the Laws of Maryland read as follows:

3 **Article – Local Government**

4 1-1318.

5 (a) (1) In this section[, “invasive】 THE FOLLOWING WORDS HAVE THE  
6 MEANINGS INDICATED.

7 (2) “**INVASIVE** bamboo” means bamboo that is characterized by  
8 aggressive spreading behavior, including bamboo species in the genus *Phyllostachys*.

9 (3) “**TREE OF HEAVEN**” MEANS THE *AILANTHUS ALTISSIMA* TREE  
10 SPECIES.

11 (b) This section applies to all counties and municipalities.

12 (c) The governing body of a county or municipality, by ordinance, may regulate  
13 invasive bamboo **OR TREES OF HEAVEN**, including by prohibiting a person from:

14 (1) selling invasive bamboo **OR TREES OF HEAVEN**;

15 (2) planting invasive bamboo **OR TREES OF HEAVEN**; [and]

16 (3) allowing invasive bamboo to grow on the property of the person without  
17 proper upkeep and appropriate containment measures, including barriers or trenches; AND

18 (4) **ALLOWING TREES OF HEAVEN TO GROW ON THE PERSON'S**  
19 **PROPERTY.**

20 (d) The governing body of a county or municipality may provide for the  
21 enforcement of an ordinance adopted under this section by:

22 (1) requiring any damages caused by invasive bamboo **OR TREES OF**  
23 **HEAVEN** to be mitigated; and

24 (2) establishing a civil fine.

25 (E) **THE GOVERNING BODY OF A COUNTY OR MUNICIPALITY MAY ESTABLISH**  
26 **A BOUNTY PROGRAM TO INCENTIVIZE THE REMOVAL OF TREES OF HEAVEN.**

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
28 October 1, 2026.
