A BILL ENTITLED

1 AN ACT concerning

2 **State and Local Employees – Cancer Screening – Paid Leave**

3 FOR the purpose of providing that State, county, and municipal employees are entitled to
4 a certain amount of cancer screening leave with pay under certain circumstances;
5 and generally relating to cancer screening leave for State, county, and municipal
6 employees.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Local Government**

20 **1–210.**

21 **(A) THIS SECTION APPLIES TO ALL EMPLOYEES OF A GOVERNMENTAL UNIT**
22 **OF A COUNTY OR A MUNICIPALITY IN THE STATE.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(B) SUBJECT TO SUBSECTION (C) OF THIS SECTION, ON REQUEST, AN**
2 **EMPLOYEE SUBJECT TO THIS SECTION IS ENTITLED TO CANCER SCREENING LEAVE**
3 **WITH PAY.**

4 **(C) AN EMPLOYEE MAY:**

5 **(1) USE UP TO 4 HOURS OF CANCER SCREENING LEAVE IN ANY**
6 **12-MONTH PERIOD FOR CANCER SCREENING; AND**

7 **(2) USE CANCER SCREENING LEAVE ONLY AFTER OBTAINING**
8 **APPROVAL FROM THE EMPLOYEE'S APPOINTING AUTHORITY.**

9 **(D) THE GOVERNING BODY OF A COUNTY OR MUNICIPALITY SHALL ADOPT**
10 **PROCEDURES GOVERNING CANCER SCREENING LEAVE, INCLUDING REGULATIONS**
11 **THAT ESTABLISH CONDITIONS AND PROCEDURES FOR REQUESTING AND**
12 **APPROVING CANCER SCREENING LEAVE.**

13 **Article – State Personnel and Pensions**

14 **9–1110.**

15 **(A) THIS SECTION APPLIES TO ALL EMPLOYEES, INCLUDING TEMPORARY**
16 **EMPLOYEES AND PART-TIME EMPLOYEES, OF ALL UNITS IN THE EXECUTIVE,**
17 **JUDICIAL, AND LEGISLATIVE BRANCHES OF STATE GOVERNMENT, INCLUDING ANY**
18 **UNIT WITH AN INDEPENDENT PERSONNEL SYSTEM.**

19 **(B) SUBJECT TO SUBSECTION (C) OF THIS SECTION, ON REQUEST, AN**
20 **EMPLOYEE SUBJECT TO THIS SECTION IS ENTITLED TO CANCER SCREENING LEAVE**
21 **WITH PAY.**

22 **(C) AN EMPLOYEE MAY:**

23 **(1) USE UP TO 4 HOURS OF CANCER SCREENING LEAVE IN ANY**
24 **12-MONTH PERIOD FOR CANCER SCREENING; AND**

25 **(2) USE CANCER SCREENING LEAVE ONLY AFTER OBTAINING**
26 **APPROVAL FROM THE EMPLOYEE'S APPOINTING AUTHORITY.**

27 **(D) THE SECRETARY SHALL ADOPT REGULATIONS GOVERNING CANCER**
28 **SCREENING LEAVE, INCLUDING REGULATIONS THAT ESTABLISH CONDITIONS AND**
29 **PROCEDURES FOR REQUESTING AND APPROVING CANCER SCREENING LEAVE.**

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
31 1, 2026.
