A BILL ENTITLED

1 AN ACT concerning

2 **Labor and Employment – Training Repayment Agreements – Prohibition**

3 FOR the purpose of prohibiting employers from requiring, as a condition of employment,
4 employees or prospective employees to enter into training repayment agreements;
5 providing that an agreement that constitutes a training repayment agreement is null
6 and void as being against the public policy of the State; and generally relating to
7 training repayment agreements.

8 BY repealing and reenacting, without amendments,

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Labor and Employment**

21 3–103.

22 (a) Except as otherwise provided in this section, the Commissioner may conduct
23 an investigation to determine whether a provision of this title has been violated on the
24 Commissioner's own initiative or may require a written complaint.

5 (A) (1) IN THIS SECTION, "TRAINING REPAYMENT AGREEMENT" MEANS
6 AN AGREEMENT THAT REQUIRES AN EMPLOYEE TO PAY AN EMPLOYER OR A THIRD
7 PARTY, SUCH AS A TRAINING PROVIDER, A SUM OF MONEY IF THE EMPLOYEE
8 VOLUNTARILY OR INVOLUNTARILY LEAVES EMPLOYMENT WITH THE EMPLOYER.

(3) "TRAINING REPAYMENT AGREEMENT" DOES NOT INCLUDE:

13 (I) A CASH ADVANCE TO AN EMPLOYEE;

14 (II) A PAYMENT FOR EQUIPMENT SOLD OR LEASED TO AN
15 EMPLOYEE;

16 (III) AN EDUCATIONAL SABBATICAL LEAVE CONTRACT; OR

17 (IV) AN AGREEMENT DESCRIBED IN PARAGRAPH (1) OF THIS
18 SUBSECTION ENTERED INTO AS PART OF A COLLECTIVE BARGAINING AGREEMENT.

19 (B) (1) AN EMPLOYER MAY NOT REQUIRE AS A CONDITION OF
20 EMPLOYMENT AN EMPLOYEE OR PROSPECTIVE EMPLOYEE TO ENTER INTO A
21 TRAINING REPAYMENT AGREEMENT.

22 (2) AN AGREEMENT THAT CONSTITUTES A TRAINING REPAYMENT
23 AGREEMENT IS NULL AND VOID AS BEING AGAINST THE PUBLIC POLICY OF THE
24 STATE.

25 (C) IF AN EMPLOYEE OR A PROSPECTIVE EMPLOYEE BELIEVES THAT AN
26 EMPLOYER HAS VIOLATED SUBSECTION (B)(1) OF THIS SECTION, THE EMPLOYEE OR
27 PROSPECTIVE EMPLOYEE MAY:

28 (1) FILE A WRITTEN COMPLAINT WITH THE COMMISSIONER; OR

29 (2) BRING A CIVIL ACTION FOR ECONOMIC DAMAGES.

(I) FOR THE FIRST VIOLATION, UP TO \$10,000;

6 (III) FOR EACH SUBSEQUENT VIOLATION, UP TO \$20,000 FOR
7 EACH EMPLOYEE FOR WHOM THE EMPLOYER IS NOT IN COMPLIANCE.

8 (2) IN DETERMINING THE AMOUNT OF THE PENALTY UNDER
9 PARAGRAPH (1) OF THIS SUBSECTION, THE COMMISSIONER SHALL CONSIDER:

10 (I) THE GRAVITY OF THE VIOLATION;

11 (II) THE SIZE OF THE EMPLOYER'S BUSINESS;

12 (III) THE EMPLOYER'S GOOD FAITH; AND

13 (IV) THE EMPLOYER'S HISTORY OF VIOLATIONS UNDER THIS
14 SECTION.

19 (E) IF A COURT IN AN ACTION FILED UNDER SUBSECTION (C)(2) OF THIS
20 SECTION DETERMINES THAT AN INDIVIDUAL OR A CLASS OF INDIVIDUALS IS
21 ENTITLED TO RESTITUTION AS A RESULT OF THE EMPLOYER'S VIOLATION OF
22 SUBSECTION (B)(1) OF THIS SECTION, THE COURT:

23 (1) SHALL AWARD EACH INDIVIDUAL ANY RESTITUTION TO WHICH
24 THE INDIVIDUAL MAY BE ENTITLED; AND

27 (F) A PENALTY ISSUED OR RESTITUTION ORDERED UNDER THIS SECTION
28 AGAINST AN EMPLOYER SHALL BE IN EFFECT AGAINST ANY SUCCESSOR BUSINESS
29 ENTITY THAT:

1 **(1) HAS ONE OR MORE OF THE SAME PRINCIPALS OR OFFICERS AS THE**
2 **EMPLOYER AGAINST WHOM THE PENALTY WAS ASSESSED, UNLESS THE PRINCIPAL**
3 **OR OFFICER DID NOT OR WITH THE EXERCISE OF REASONABLE DILIGENCE COULD**
4 **NOT KNOW OF THE VIOLATION FOR WHICH THE PENALTY WAS IMPOSED; AND**

5 **(2) IS ENGAGED IN THE SAME OR EQUIVALENT TRADE OR ACTIVITY.**

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 October 1, 2026.
