A BILL ENTITLED

1 AN ACT concerning

2 **General Provisions – Commemorative Month – Maryland Native Plant Month**

3 FOR the purpose of requiring the Governor to annually proclaim a certain month as
4 Maryland Native Plant Month; requiring the proclamation to urge educational and
5 environmental organizations and businesses to observe Maryland Native Plant
6 Month properly; and generally relating to Maryland Native Plant Month.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
24 That Section(s) 7–504 through 7–507 of Article – General Provisions of the Annotated Code
25 of Maryland be renumbered to be Section(s) 7–505 through 7–508, respectively.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
2 as follows:

3 **Article – Agriculture**

4 10–401.

5 (a) In this subtitle the following words have the meanings indicated.

6 (c) (1) “Native plant” means a plant that occurs naturally in the State and
7 surrounding region, ecosystem, and habitat, without direct or indirect human actions.

8 (2) “Native plant” includes a plant that:

9 (i) Was present before colonial settlement; or

10 (ii) Is listed as native to Maryland on the Maryland Plant Atlas
11 website.

12 **Article – General Provisions**

13 **7–504.**

14 **(A) IN THIS SECTION, “NATIVE PLANT” HAS THE MEANING STATED IN §**
15 **10–401 OF THE AGRICULTURE ARTICLE.**

16 **(B) THE GOVERNOR ANNUALLY SHALL PROCLAIM THE MONTH OF MAY AS**
17 **MARYLAND NATIVE PLANT MONTH IN RECOGNITION OF THE BENEFITS THAT**
18 **NATIVE PLANTS HAVE ON MARYLAND’S NATURAL ENVIRONMENT.**

19 **(C) THE PROCLAMATION SHALL URGE EDUCATIONAL AND ENVIRONMENTAL**
20 **ORGANIZATIONS AND BUSINESSES TO OBSERVE MARYLAND NATIVE PLANT MONTH**
21 **PROPERLY WITH APPROPRIATE PROGRAMS, EVENTS, AND ACTIVITIES.**

22 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2026.
