CHAPTER _____

1 AN ACT concerning

2 **Video Tolls – Class G (Trailer) Vehicles – Liability**

3 FOR the purpose of establishing that the registered owner of a Class G (trailer) vehicle is
4 liable under certain circumstances to the Maryland Transportation Authority for
5 payment of a video toll assessed at the time of passage through a toll collection
6 facility, subject to certain standards and procedures for the transfer of liability; and
7 generally relating to liability for the payment of video tolls.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

3 (a) (1) When registered with the Administration, every trailer and semitrailer
4 is a Class G (trailer) vehicle.

5 21–1414.

6 (a) (1) In this section the following words have the meanings indicated.

7 (2) “Authority” means the Maryland Transportation Authority

8 (3) “Electronic toll collection” means a system in a toll collection facility
9 that is capable of collecting information from a motor vehicle **OR CLASS G (TRAILER)**
10 **VEHICLE** for use in charging tolls.

11 (4) “Notice of toll due” or “notice” means an administrative notice of a video
12 toll transaction.

13 (5) “Person alleged to be liable” means:

14 (i) The registered owner of a motor vehicle **OR CLASS G (TRAILER)**
15 **VEHICLE** involved in a video toll transaction; or

16 (ii) A person to whom a registered owner of a motor vehicle **OR**
17 **CLASS G (TRAILER) VEHICLE** has transferred liability for a video toll transaction in
18 accordance with this section and the regulations of the Authority.

19 (6) “Recorded image” means an image of a motor vehicle **OR CLASS G**
20 **(TRAILER) VEHICLE** passing through a toll collection facility recorded by a video
21 monitoring system:

22 (i) On:

23 1. One or more photographs, micrographs, or electronic
24 images;

25 2. Videotape; or

26 3. Any other medium; and

27 (ii) Showing either the front or rear of the motor vehicle **OR CLASS**
28 **G (TRAILER) VEHICLE** on at least one image or portion of tape and clearly identifying the

1 [license] REGISTRATION plate number and state of the motor vehicle **OR CLASS G**
2 **(TRAILER) VEHICLE**.

3 (7) "Registered owner" means, with respect to a motor vehicle **OR CLASS**
4 **G (TRAILER) VEHICLE**, the person or persons designated as the registered owner in the
5 records of the government agency that is responsible for motor vehicle **OR CLASS G**
6 **(TRAILER) VEHICLE** registration.

7 (8) "Toll collection facility" means any point on an Authority highway
8 where a toll is incurred and is required to be paid.

9 (9) "Toll violation" means the failure to pay a video toll within the time
10 prescribed by the Authority in a notice of toll due.

11 (10) "Video monitoring system" means a device installed to work in
12 conjunction with a toll collection facility that produces a recorded image when a video toll
13 transaction occurs.

14 (11) "Video toll" means the amount assessed by the Authority when a video
15 toll transaction occurs.

16 (12) "Video toll transaction" means any transaction in which a motor vehicle
17 **OR CLASS G (TRAILER) VEHICLE** does not or did not pay a toll at the time of passage
18 through a toll collection facility with a video monitoring system.

19 (b) (1) Except as provided in subsection (g) of this section, the registered owner
20 of a motor vehicle **OR, IF THE REGISTERED OWNER OF THE MOTOR VEHICLE CANNOT**
21 **BE DETERMINED, CLASS G (TRAILER) VEHICLE** shall be liable to the Authority for
22 payment of a video toll as provided for in the regulations of the Authority.

23 (2) The Authority shall send the registered owner of a motor vehicle **OR**
24 **CLASS G (TRAILER) VEHICLE** that has incurred a video toll a notice of toll due.

25 (3) Except as provided in subsection (g) of this section, the person alleged
26 to be liable who receives a notice of toll due shall have at least 30 days to pay the video toll.

27 (4) To mail the notice of toll due, the Authority shall use:

28 (i) The current mailing address on file with the Administration; or

29 (ii) If a mailing address is unavailable, the current residential
30 address on file with the Administration.

31 (c) (1) Failure of the person alleged to be liable to pay the video toll under a
32 notice of toll due by the date stated on the notice shall constitute a toll violation subject to

1 a civil citation and a civil penalty, which shall be assessed 15 days after the toll violation
2 occurs, as provided for in the regulations of the Authority.

3 (2) A registered owner of a motor vehicle [shall] **OR CLASS G (TRAILER)**
4 **VEHICLE MAY** not be liable for a civil penalty imposed under this section if the operator of
5 the motor vehicle **OR MOTOR VEHICLE TOWING THE CLASS G (TRAILER) VEHICLE** has
6 been convicted of failure or refusal to pay a toll under § 21-1413 of this subtitle for the
7 same violation.

8 (d) (1) (i) The Authority or its duly authorized agent shall send a citation
9 via first-class mail, no later than 60 days after the toll violation, to the person alleged to
10 be liable under this section.

11 (ii) To mail the citation, the Authority or its duly authorized agent
12 shall use:

13 1. The current mailing address on file with the
14 Administration; or

15 2. If a mailing address is unavailable, the current residential
16 address on file with the Administration.

17 (2) Personal service of the citation on the person alleged to be liable shall
18 not be required, and a record of mailing kept in the ordinary course of business shall be
19 admissible evidence of the mailing of the notice of toll due and citation.

20 (3) A citation shall contain:

21 (i) The name and address of the person alleged to be liable under
22 this section;

23 (ii) The [license] **REGISTRATION** plate number and state of
24 registration of the motor vehicle **OR CLASS G (TRAILER) VEHICLE** involved in the video
25 toll transaction;

26 (iii) The location where the video toll transaction took place;

27 (iv) The date and time of the video toll transaction;

28 (v) The amount of the video toll and the date it was due as stated on
29 the notice of toll due;

30 (vi) A copy of the recorded image;

31 (vii) A statement that the video toll was not paid before the civil
32 penalty was assessed;

1 (viii) The amount of the civil penalty; and

2 (ix) The date by which the video toll and civil penalty must be paid.

3 (4) A citation shall also include:

4 (i) Information advising the person alleged to be liable under this
5 section of the manner and the time in which liability alleged in the citation may be
6 contested;

7 (ii) The statutory defenses described in subsection (g) of this section
8 that were originally included in the notice of toll due; and

9 (iii) A warning that failure to pay the video toll and civil penalty, to
10 contest liability in the manner and time prescribed, or to appear at a trial requested is an
11 admission of liability and a waiver of available defenses and may result in the refusal or
12 suspension of the motor vehicle **OR CLASS G (TRAILER) VEHICLE** registration and
13 referral for collection.

14 (5) A person alleged to be liable receiving the citation for a toll violation
15 under this section may:

16 (i) Pay the video toll and the civil penalty directly to the Authority;

17 (ii) Request to pay the video toll and civil penalty through the
18 installment plan under § 21-1417 of this subtitle; or

19 (iii) Elect to stand trial for the alleged violation.

20 (6) (i) If the person alleged to be liable under this section fails to elect
21 to stand trial or to appear at trial after having elected to stand trial, fails to pay the
22 prescribed video toll and civil penalty within 30 days after mailing of the citation or in
23 accordance with an installment payment plan approved by the Authority, or is adjudicated
24 to be liable after trial, the Authority or its duly authorized agent may:

25 1. Collect the video toll and the civil penalty by any means of
26 collection as provided by law; and

27 2. Notify the Administration of the failure to pay the video
28 toll and civil penalty in accordance with subsection (i) of this section.

29 (ii) No additional hearing or proceeding is required before the
30 Administration takes action with respect to the motor vehicle **OR CLASS G (TRAILER)**
31 **VEHICLE** of the registered owner under subsection (i) of this section.

1 (e) (1) A certificate alleging that a toll violation occurred and that the video
2 toll payment was not received before the civil penalty was assessed, sworn to or affirmed
3 by a duly authorized agent of the Authority, based upon inspection of a recorded image and
4 electronic toll collection records produced by an electronic toll collection video monitoring
5 system shall be evidence of the facts contained therein and shall be admissible in any
6 proceeding alleging a violation under this section without the presence or testimony of the
7 duly authorized agent who performed the requirements under this section.

8 (2) The citation, including the certificate, shall constitute prima facie
9 evidence of liability for the toll violation and civil penalty.

10 (f) Adjudication of liability under this section:

11 (1) Shall be based upon a preponderance of evidence;

12 (2) May not be deemed a conviction of a registered owner of a motor vehicle
13 **OR CLASS G (TRAILER) VEHICLE** under the [Motor Vehicle Code] **MARYLAND VEHICLE**
14 **LAW**;

15 (3) May not be made part of the registered owner's motor vehicle operating
16 record; and

17 (4) May not be considered in the provision of motor vehicle insurance
18 coverage.

19 (g) (1) If, at the time of a video toll transaction, a motor vehicle **OR CLASS G**
20 **(TRAILER) VEHICLE** is operated by a person other than the registered owner without the
21 express or implied consent of the registered owner, and if the registered owner by the date
22 stated on the notice of toll due provides the Authority or its duly authorized agent with a
23 notarized admission by the person accepting liability which shall include that person's
24 name, address, and driver's license identification number, then the person accepting
25 liability shall be liable under this section and shall be sent a notice of toll due.

26 (2) If the registered owner is a lessor of motor vehicles **OR CLASS G**
27 **(TRAILER) VEHICLES**, and at the time of the video toll transaction the motor vehicle **OR**
28 **CLASS G (TRAILER) VEHICLE** involved was in the possession of a lessee, and the lessor
29 by the date stated on the notice of toll due provides the Authority or its duly authorized
30 agent with a copy of the lease agreement or other documentation acceptable to the
31 Authority identifying the lessee, including the person's name, address, and driver's license
32 identification number or federal employer identification number, then the lessee shall be
33 liable under this section and shall be sent a notice of toll due.

34 (3) If the motor vehicle **OR CLASS G (TRAILER) VEHICLE** involved in a
35 video toll transaction is operated using a dealer or transporter registration plate, and at
36 the time of the video toll transaction the motor vehicle **OR CLASS G (TRAILER) VEHICLE**
37 was under the custody and control of a person other than the owner of the dealer or

1 transporter registration plate, and if the owner of the dealer or transporter registration
2 plate by the date stated on the notice of toll due provides to the Authority or its duly
3 authorized agent a copy of the contractual agreement or other documentation acceptable to
4 the Authority identifying the person, including the person's name, address, and driver's
5 license identification number, who had custody and control over the motor vehicle **OR**
6 **CLASS G (TRAILER) VEHICLE** at the time of the video toll transaction, then that person
7 and not the owner of the dealer or transporter registration plate shall be liable under this
8 section and shall be sent a notice of toll due.

9 (4) **IF A CLASS G (TRAILER) VEHICLE INVOLVED IN A VIDEO TOLL**
10 **TRANSACTION WAS BEING TOWED BY A MOTOR VEHICLE AT THE TIME OF THE VIDEO**
11 **TOLL TRANSACTION, AND IF THE REGISTERED OWNER OF THE CLASS G (TRAILER)**
12 **VEHICLE BY THE DATE STATED ON THE NOTICE OF TOLL DUE PROVIDES TO THE**
13 **AUTHORITY OR ITS DULY AUTHORIZED AGENT A COPY OF THE CONTRACTUAL**
14 **AGREEMENT OR OTHER DOCUMENTATION ACCEPTABLE TO THE AUTHORITY**
15 **IDENTIFYING THE PERSON OPERATING THE TOW VEHICLE, INCLUDING THE**
16 **PERSON'S NAME, ADDRESS, AND DRIVER'S LICENSE IDENTIFICATION NUMBER, WHO**
17 **HAD CUSTODY AND CONTROL OVER THE CLASS G (TRAILER) VEHICLE AT THE TIME**
18 **OF THE VIDEO TOLL TRANSACTION, THEN THAT PERSON AND NOT THE OWNER OF**
19 **THE CLASS G (TRAILER) VEHICLE SHALL BE LIABLE UNDER THIS SECTION AND**
20 **SHALL BE SENT A NOTICE OF TOLL DUE.**

21 (5) If a motor vehicle, **CLASS G (TRAILER) VEHICLE**, or registration plate
22 [number] **OF A MOTOR VEHICLE OR CLASS G (TRAILER) VEHICLE** is reported to a law
23 enforcement agency as stolen at the time of the video toll transaction, and the registered
24 owner by the date stated on the notice of toll due provides to the Authority or its duly
25 authorized agent a copy of the police report substantiating that the motor vehicle, **CLASS**
26 **G (TRAILER) VEHICLE, OR REGISTRATION PLATE OF THE MOTOR VEHICLE OR CLASS**
27 **G (TRAILER) VEHICLE** was stolen at the time of the video toll transaction, then the
28 registered owner of the motor vehicle **OR CLASS G (TRAILER) VEHICLE** is not liable under
29 this section.

30 (h) (1) The Authority may refer a delinquent account for unpaid video tolls and
31 associated civil penalties to the Central Collection Unit for collection.

32 (2) The Authority may recall a delinquent account from the Central
33 Collection Unit if:

34 (i) The delinquent account exceeds \$300 in unpaid video tolls and
35 associated civil penalties;

36 (ii) The video tolls in question were assessed within a 30-day period;

37 or

1 (iii) Mitigating factors exist with respect to the assessment of the
2 unpaid video tolls and associated civil penalties, as determined by the Authority.

3 (3) Notwithstanding any other provision of law, until the Authority refers
4 the debt to the Central Collection Unit or after the Authority has recalled a delinquent
5 account from the Central Collection Unit, the Authority:

6 (i) May waive any portion of the video toll due or civil penalty
7 assessed under this section; and

8 (ii) Shall:

9 1. Waive the civil penalty associated with a video toll on
10 payment of the video toll in accordance with the Authority's Customer Assistance Plan as
11 approved on February 24, 2022; and

12 2. Reimburse any civil penalty paid in error under the Plan.

13 (i) (1) The Administration shall refuse or suspend the registration of a motor
14 vehicle **OR CLASS G (TRAILER) VEHICLE** that incurs a toll violation under this section if:

15 (i) The [Maryland Transportation] Authority notifies the
16 Administration that a registered owner of the motor vehicle **OR CLASS G (TRAILER)**
17 **VEHICLE** has been served with a citation in accordance with this section and has failed to:

18 1. Pay the video toll and the civil penalty for the toll violation
19 by the date specified in the citation; **[and] OR**

20 2. Contest liability for the toll violation by the date identified
21 and in the manner specified in the citation; or

22 (ii) The [Maryland Transportation] Authority or the District Court
23 notifies the Administration that a person who elected to contest liability for a toll violation
24 under this section **[has failed to]:**

25 1. **[Appear] HAS FAILED TO APPEAR** for trial or has been
26 determined to be guilty of the toll violation; and

27 2. **[Pay] HAS FAILED TO PAY** the video toll and civil penalty.

28 (2) In conjunction with the [Maryland Transportation] Authority, the
29 Administration may adopt regulations and develop procedures to carry out the refusal or
30 suspension of a registration under this subsection.

31 (3) The procedures in this subsection are in addition to any other penalty
32 provided by law for a toll violation under this section.

1 (4) This subsection may be applied to enforce a reciprocal agreement
2 entered into by the State and another jurisdiction in accordance with § 21-1415 of this
3 subtitle.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 January 1, 2027.
