1 AN ACT concerning

2 **Motor Vehicles – Speed Monitoring Systems – Safety Corridors**  
3 **(Vulnerable Road User Protection Act of 2026)**

4 FOR the purpose of authorizing the State Highway Administration to implement a program  
5 of safety corridor speed monitoring systems for use in areas determined to be of high  
6 risk to vulnerable road users; authorizing a local jurisdiction to use speed monitoring  
7 systems in safety corridors under certain circumstances; and generally relating to  
8 the use of speed monitoring systems in safety corridors.

20 to the District Court having venue a copy of the citation and a copy of the notice from the  
21 person who received the citation indicating the person's intention to stand trial.

23 trial and notify the defendant of the trial date under procedures adopted by the Chief Judge

23 places a mobile or stationary speed monitoring system to or at a location where a speed

25 issue a citation for a violation recorded by that speed monitoring system:

26                           1. Until signage is installed in accordance with

31 **SAFETY CORRIDOR ALERTING DRIVERS THAT A SPEED MONITORING SYSTEM MAY BE**  
32 **IN OPERATION IN THE SAFETY CORRIDOR.**

33                   **(II) A SAFETY CORRIDOR SPEED MONITORING SYSTEM**  
34 **OPERATOR DOES NOT NEED TO BE PRESENT IN PERSON OR REMOTELY AT THE**

1 SAFETY CORRIDOR WHEN A SAFETY CORRIDOR SPEED MONITORING SYSTEM IS IN  
2 USE.

3 (III) A SAFETY CORRIDOR SPEED MONITORING SYSTEM MAY BE  
4 A MOBILE UNIT OR A STATIONARY UNIT.

5 (3) A SAFETY CORRIDOR SPEED MONITORING SYSTEM MAY BE USED  
6 ONLY TO RECORD THE IMAGES OF VEHICLES THAT ARE TRAVELING AT SPEEDS AT  
7 LEAST 12 MILES PER HOUR ABOVE THE POSTED SPEED LIMIT.
