## A BILL ENTITLED

1 AN ACT concerning

2 **Sports Wagering Proceeds – Promotional Play Exclusion – Limitation**

3 FOR the purpose of authorizing the State Lottery and Gaming Control Commission to  
4 establish a certain limit, by regulation, on the amount of money given away as free  
5 promotional play by a sports wagering licensee that may be excluded from sports  
6 wagering proceeds; and generally relating to proceeds from sports wagering.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

19 **Article – State Government**

20 9–1E–01.

21 (a) In this subtitle the following words have the meanings indicated.

(h) (1) "Proceeds" means the amount of money wagered on a sporting event, less:

[(1)] (I) the amount returned to successful bettors;

[(2)] (II) the cash equivalents of any merchandise or thing of value awarded as a prize to successful bettors; AND

[(3)] free bets and promotional credits redeemed by bettors; and

[(4)] (III) all excise taxes paid by a sports wagering licensee in accordance with federal law.

(2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, "PROCEEDS" DOES NOT INCLUDE MONEY GIVEN AWAY BY A SPORTS WAGERING LICENSEE AS FREE PROMOTIONAL PLAY AND USED BY PLAYERS TO BET ON A SPORTING EVENT.

(II) AFTER THE FIRST FULL FISCAL YEAR OF OPERATIONS, THE EXCLUSION SPECIFIED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH MAY NOT EXCEED A PERCENTAGE, ESTABLISHED BY THE COMMISSION BY REGULATION, OF:

1. THE TOTAL SPORTS WAGERING PROCEEDS RETAINED BY THE SPORTS WAGERING FACILITY LICENSEE IN THE PRIOR FISCAL YEAR UNDER § 9-1E-12(B)(1)(II) OR (III) OF THIS SUBTITLE; OR

2. THE TOTAL ONLINE SPORTS WAGERING PROCEEDS RETAINED BY THE MOBILE SPORTS WAGERING LICENSEE IN THE PRIOR FISCAL YEAR UNDER § 9-1E-12(B)(1)(IV) OF THIS SUBTITLE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2026.
