## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland–National Capital Park and Planning Commission and Washington**  
3 **Suburban Sanitary Commission – Vendor Registration**

4 **PG/MC 107–26**

5 FOR the purpose of requiring the Maryland–National Capital Park and Planning  
6 Commission and the Washington Suburban Sanitary Commission to accept as a  
7 registered vendor any person that is registered as a vendor with Montgomery County  
8 or Prince George's County; authorizing the Maryland–National Capital Park and  
9 Planning Commission and the Washington Suburban Sanitary Commission to enter  
10 into certain memoranda of understanding with Montgomery County and Prince  
11 George's County; and generally relating to procurement by the Maryland–National  
12 Capital Park and Planning Commission and the Washington Suburban Sanitary  
13 Commission.

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
9 That the Laws of Maryland read as follows:

30 **COMMISSION ANY PERSON THAT IS REGISTERED AS A VENDOR THROUGH A VENDOR**

1   REGISTRATION PROCESS IN MONTGOMERY COUNTY OR PRINCE GEORGE'S  
2   COUNTY.

3           (B)   THE COMMISSION MAY ENTER INTO MEMORANDA OF UNDERSTANDING  
4   WITH MONTGOMERY COUNTY AND PRINCE GEORGE'S COUNTY TO IMPLEMENT THIS  
5   SECTION.

6           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
7   October 1, 2026.
