A BILL ENTITLED

1 AN ACT concerning

2 **Education – Professional Standards and Teacher Education Board –**
3 **Composition**

4 FOR the purpose of altering the composition of the Professional Standards and Teacher
5 Education Board by removing a member who is a certified nonpublic school
6 classroom teacher and increasing the number of members of the Maryland
7 Association of Nonpublic Special Education Facilities; and generally relating to the
8 composition of the Professional Standards and Teacher Education Board.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Education**

17 6–703.

18 (a) (1) The Board consists of the following members:

19 (i) Eight public school classroom teachers, as follows:

20 1. Six chosen from a list of nominees provided by the
21 statewide teachers' organization representing a majority of teachers in the State for
22 collective bargaining purposes; and

2. Two chosen from a list of nominees provided by a statewide teachers' organization representing teachers in at least one jurisdiction within the State for collective bargaining purposes other than the majority organization provided for in item 1 of this item;

5 (ii) [One certified nonpublic school classroom teacher, chosen from a
6 list of nominees provided by the Association of Independent Schools;

(iii)] Six teacher education faculty members from colleges of the State, chosen from a list of nominees provided by:

9 1. The Maryland Association of Teacher Educators; and

2. The Maryland Association of Colleges of Teacher

(III) Four administrative or supervisory staff members of

1. Two chosen from a list of nominees provided by the Public Association of Maryland;

2. One chosen from a list of nominees provided by the Secondary Principals; and

3. One chosen from a list of nominees provided by the Elementary School Administrators;

(IV) One administrative or supervisory staff of the approved State, chosen from a list of nominees provided by the Association

(v) One member of a local board of education, chosen from a by the Maryland Association of Boards of Education:

(vi) [One member] TWO MEMBERS of the Maryland
Special Education Facilities, chosen from a list of nominees
and Association of Nonpublic Special Education Facilities:

1 (VII) Two representatives of the general public, as follows:

1. One chosen from a list of nominees provided by the Delegates of Maryland; and

2. One chosen from a list of nominees provided by the
of Maryland; and

(2) In making the appointments required under this subsection, the Governor shall ensure that the Board is representative of:

10 (i) The geographic regions of the State; and

13 (c) (1) The term of an appointed member is 3 years.

14 (2) The terms of the appointed members are staggered as required by the
15 terms provided for members of the Board on October 1, 1991.

16 (3) At the end of a term, a member continues to serve until a successor is
17 appointed.

18 (4) A member who is appointed after a term has begun serves only for the
19 remainder of the term and until a successor is appointed and qualifies.

20 (d) The Governor may remove a member for incompetence or misconduct.

21 (e) From among its members, the Board annually shall elect a chairman.

22 (f) A majority of the members of the Board then serving on the Board is a quorum.

23 (g) The staff for the Board shall be provided by the State Board.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2026.
