1 AN ACT concerning

2 **General Assembly Vacancy – Political Party Central Committee – Procedures**

3 FOR the purpose of establishing requirements for the filling of a vacancy in the office of
4 Senator or Delegate in the General Assembly by a central committee of a political
5 party under the Maryland Constitution relating to applications, public notice, public
6 meetings, and voting; and generally relating to the procedures of a central committee
7 of a political party for filling a vacancy in the General Assembly.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Election Law**

2 Except as to a matter of compelling State interest **OR WITH RESPECT TO A**
3 **CONFLICT WITH § 4-206 OF THIS TITLE**, if any provision of this title relating to party
4 governance conflicts with the constitution and bylaws of a political party, the constitution
5 and bylaws shall apply to the extent of the conflict.

6 **4-206.**

7 **(A) THIS SECTION APPLIES ONLY TO THE PROCESS OF FILLING A VACANCY**
8 **IN THE OFFICE OF SENATOR OR DELEGATE IN THE GENERAL ASSEMBLY UNDER**
9 **ARTICLE III, § 13 OF THE MARYLAND CONSTITUTION.**

10 **(B) (1) THE APPLICATION PERIOD TO APPLY TO A CENTRAL COMMITTEE**
11 **TO FILL A VACANCY SHALL BE:**

12 **(I) OPEN FOR AT LEAST 7 DAYS; AND**

13 **(II) ADVERTISED IN A CONSPICUOUS MANNER BY THE CENTRAL**
14 **COMMITTEE FILLING THE VACANCY BY A PUBLIC NOTICE THAT INCLUDES:**

15 **1. THE CENTRAL COMMITTEE'S INTENT TO MEET TO FILL**
16 **THE VACANCY;**

17 **2. THE TIME AND PLACE OF ANY MEETINGS TO BE HELD**
18 **TO DISCUSS OR VOTE ON THE FILLING OF THE VACANCY;**

19 **3. THE PROCESS FOR FILLING THE VACANCY; AND**

20 **4. THE MANNER IN WHICH INDIVIDUALS MAY APPLY TO**
21 **FILL THE VACANCY.**

22 **(2) THE NOTICE REQUIRED UNDER PARAGRAPH (1)(II) OF THIS**
23 **SUBSECTION SHALL BE TRANSLATED INTO A LANGUAGE OTHER THAN ENGLISH IF**
24 **THE LOCAL BOARD FOR THE COUNTY IN WHICH THE CENTRAL COMMITTEE IS**
25 **LOCATED IS REQUIRED TO TRANSLATE ELECTION MATERIALS INTO THAT LANGUAGE**
26 **UNDER § 203 OF THE FEDERAL VOTING RIGHTS ACT.**

27 **(C) (1) ALL APPLICATIONS SUBMITTED TO A CENTRAL COMMITTEE TO**
28 **FILL A VACANCY SHALL:**

29 **(I) BE POSTED ONLINE PROMPTLY AFTER THE APPLICATION**
30 **DEADLINE BY THE COUNTY CENTRAL COMMITTEE OR THE STATE CENTRAL**
31 **COMMITTEE OF THE POLITICAL PARTY; AND**

1 **(II) REMAIN POSTED ONLINE UNTIL AT LEAST 30 DAYS AFTER**
2 **THE CENTRAL COMMITTEE VOTES ON AN INDIVIDUAL TO FILL THE VACANCY.**

3 **(2) THE CENTRAL COMMITTEE MAY REDACT PERSONAL**
4 **INFORMATION FROM THE APPLICATIONS POSTED ONLINE UNDER PARAGRAPH (1)**
5 **OF THIS SUBSECTION.**

6 **(D) THE CENTRAL COMMITTEE SHALL HOLD A PUBLIC MEETING TO**
7 **INTERVIEW THE INDIVIDUALS WHO APPLIED TO FILL THE VACANCY.**

8 **(E) A MEETING HELD BY A CENTRAL COMMITTEE TO DISCUSS OR VOTE ON**
9 **FILLING A VACANCY SHALL BE:**

10 **(1) OPEN TO THE PUBLIC; AND**

11 **(2) ANNOUNCED AT LEAST 3 DAYS BEFORE THE MEETING.**

12 **(F) (1) THE VOTE BY A CENTRAL COMMITTEE TO CHOOSE AN INDIVIDUAL**
13 **TO FILL A VACANCY SHALL BE:**

14 **(I) BY ROLL CALL VOTE OR BY SIGNED BALLOTS; AND**

15 **(II) IN A MEETING OPEN TO THE PUBLIC.**

16 **(2) A MEMBER OF THE CENTRAL COMMITTEE WHO HAS APPLIED TO**
17 **FILL THE VACANCY SHALL RECUSE THEMSELVES FROM:**

18 **(I) ADMINISTERING THE PROCESS OF FILLING THE VACANCY,**
19 **INCLUDING ADVERTISING THE VACANCY, REVIEWING APPLICATIONS, AND**
20 **INTERVIEWING CANDIDATES; AND**

21 **(II) VOTING ON THE INDIVIDUAL TO FILL THE VACANCY.**

22 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
23 **October 1, 2026.**
