2 **State Acupuncture Board – Revisions**

3 FOR the purpose of ~~defining “manual therapies” as it relates to the practice of acupuncture;~~
4 requiring the State Acupuncture Board to make available proof of renewal, rather
5 than issuing a renewal certificate; prohibiting a person from employing an individual
6 to practice acupuncture without a license or aiding or abetting the unauthorized
7 practice of acupuncture; and generally relating to the practice of acupuncture.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

24 ~~(i) Stimulation of the body by the insertion of needles;~~

30 ~~(1) A formalized professional relationship between a licensed~~
 31 ~~acupuncturist and an individual performing auricular detoxification that provides~~

~~evaluation and direction of the individual to adequately ensure the safety and welfare of clients during the course of treatment; and~~

~~(2) As defined by the Board in regulations:~~

~~(i) Periodic direct supervision where the licensed acupuncturist is present or on-site during treatment; and~~

~~(ii) General supervision where the licensed acupuncturist is neither present nor on-site during treatment.~~

(b) The applicant shall:

(1) Be of good moral character;

(2) Be at least 18 years old;

(3) Demonstrate competence in performing acupuncture by meeting the following standards for education or training:

(i) If the applicant is issued a license on or before May 31, 2026:

1. Graduation from at least a master's level program or its equivalent in acupuncture that is:

A. Approved by the Maryland Higher Education Commission;

B. Accredited by the Accreditation Commission for Acupuncture and [Oriental] **HERBAL** Medicine; or

C. Found by the Board to be equivalent to a course approved or accredited under item A or B of this item; or

2. Achievement of a:

A. Diplomate in acupuncture from the National Certification Commission for Acupuncture and Oriental Medicine; or

B. Passing score on an examination that is determined by the Board to be equivalent to the examination given by the National Certification Commission for Acupuncture and Oriental Medicine; or

(ii) If the applicant is issued a license on or after June 1, 2026:

1 1. Graduation from at least a master's level program or its
2 equivalent in acupuncture that is:

3 A. Approved by the Maryland Higher Education
4 Commission;

5 B. Accredited by the Accreditation Commission for
6 Acupuncture and [Oriental] **HERBAL** Medicine; or

7 C. Found by the Board to be equivalent to a course approved
8 or accredited under item A or B of this item; and

9 2. Achievement of a passing score on an examination given
10 by the National Certification Commission for Acupuncture and Oriental Medicine or
11 determined by the Board to be equivalent to the examination given by the National
12 Certification Commission for Acupuncture and Oriental Medicine;

13 (4) Demonstrate the ability to communicate in the English language; and

14 (5) Meet any other qualifications that the Board establishes in regulations.

16 (e) The Board shall renew the license of and [issue a renewal certificate] **MAKE**
17 **AVAILABLE PROOF OF RENEWAL** to each licensee who meets the requirements of this
18 section.

20 **EXCEPT AS OTHERWISE PROVIDED IN THIS TITLE, A PERSON MAY NOT:**

21 **(1) EMPLOY AN INDIVIDUAL TO PRACTICE ACUPUNCTURE WITHOUT A**
22 **LICENSE; OR**

23 **(2) AID OR ABET THE UNAUTHORIZED PRACTICE OF ACUPUNCTURE**
24 **IN VIOLATION OF § 1A-401 OF THIS SUBTITLE.**

26 (a) A person who violates [any provision] **§ 1A-401 OR § 1A-402** of this subtitle
27 is [guilty]:

28 **(1) GUILTY** of a misdemeanor and on conviction is subject to a fine not
29 exceeding \$5,000 or imprisonment not exceeding 3 years or both[.

1 (b) A person who violates § 1A-401 or § 1A-402 of this subtitle is subject]; AND

2 (2) SUBJECT to a civil fine not to exceed \$50,000 to be assessed by the
3 Board in accordance with regulations adopted by the Board.

4 (B) A PERSON WHO VIOLATES § 1A-403 OF THIS SUBTITLE IS:

5 (1) (I) FOR A FIRST OFFENSE, GUILTY OF A MISDEMEANOR AND ON
6 CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$5,000 OR IMPRISONMENT NOT
7 EXCEEDING 1 YEAR OR BOTH; AND

8 (II) FOR A SUBSEQUENT OFFENSE, GUILTY OF A FELONY AND ON
9 CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$5,000 PER DAY OR
10 IMPRISONMENT NOT EXCEEDING 5 YEARS OR BOTH; AND

11 (2) SUBJECT TO A CIVIL FINE NOT TO EXCEED \$10,000 TO BE
12 ASSESSED BY THE BOARD IN ACCORDANCE WITH REGULATIONS ADOPTED BY THE
13 BOARD.

14 (C) THE BOARD SHALL REMIT ANY PENALTY COLLECTED UNDER THIS
15 SECTION INTO THE GENERAL FUND OF THE STATE.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2026.
