## A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt – Maryland Consolidated Capital Bond Loan of 2026,**  
3 **and the Maryland Consolidated Capital Bond Loans of 2015, 2016, 2017, 2018,**  
4 **2019, 2020, 2021, 2022, 2023, 2024, and 2025**

5 FOR the purpose of authorizing the creation of a State Debt in the amount of One Billion,  
6 Eight Hundred and Twenty-Four Million, Seven Hundred and Eighty-Two  
7 Thousand Dollars (\$1,824,782,000), the proceeds to be used for certain necessary  
8 building, construction, demolition, planning, renovation, conversion, replacement,  
9 and capital equipment purchases of the State, for acquiring certain real estate in  
10 connection therewith, and for grants to certain subdivisions and other organizations  
11 for certain development and improvement purposes; subject to certain requirements  
12 that certain matching funds be provided and expended by certain dates; providing  
13 generally for the issuance and sale of bonds evidencing the loan; imposing a certain  
14 tax on all assessable property in the State; requiring that certain grantees convey  
15 certain easements under certain circumstances to the Maryland Historical Trust;  
16 providing that the proceeds of certain loans must be expended or encumbered by a  
17 certain date; providing that certain funds may be used only for certain purposes;  
18 requiring the Department of General Services to record certain correct information  
19 in certain grant agreements under certain circumstances, notwithstanding certain  
20 differences; authorizing the Board of Public Works, under certain circumstances, to  
21 approve certain appropriations, notwithstanding certain differences; authorizing  
22 certain unexpended appropriations in certain prior capital budgets and bond loans  
23 to be expended for other public projects; altering certain requirements for certain  
24 programs in certain prior capital budgets and bond loans; reducing prior  
25 authorizations of State Debt; requiring that certain projects be constructed at certain  
26 locations; adding, altering, and repealing certain requirements for certain  
27 appropriations; altering and expanding the authorized purpose of certain grants;  
28 providing that certain grants may not terminate before certain dates; authorizing  
29 premiums from the sale of State bonds in certain fiscal years to be used for certain  
30 purposes; requiring the Comptroller to make certain transfers, adjustments, and  
31 reconciliations; repealing certain Maryland Consolidated Capital Bond Loan

36 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
37 That:

1       (1) The Board of Public Works may borrow money and incur indebtedness on  
2 behalf of the State of Maryland through a State loan to be known as the Maryland  
3 Consolidated Capital Bond Loan of 2026 in the total principal amount of \$1,824,782,000.  
4 This loan shall be evidenced by the issuance, sale, and delivery of State general obligation  
5 bonds authorized by a resolution of the Board of Public Works and issued, sold, and  
6 delivered in accordance with §§ 8-117 through 8-124 and 8-131.2 of the State Finance and  
7 Procurement Article.

(2) The bonds to evidence this loan or installments of this loan may be sold as a single issue of bonds under § 8-122 of the State Finance and Procurement Article.

10       (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and  
11 first shall be applied to the payment of the expenses of issuing, selling, and delivering the  
12 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on  
13 the books of the Comptroller and expended on approval by the Board of Public Works, for  
14 the following public purposes, including any applicable architects' and engineers' fees:
