1 AN ACT concerning

2 **State Retirement and Pension System – Transfers Between Systems –**  
3 **Workgroup – Extension**

4 FOR the purpose of extending the reporting date and the termination date for a workgroup  
5 convened by the State Retirement Agency to study transfers of member service  
6 between State and local retirement and pension systems; altering the entities to  
7 which the State Retirement Agency is required to report; and generally relating to  
8 transfers of member service between State and local retirement and pension  
9 systems.

15 **JOINT COMMITTEE ON PENSIONS.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
17 1, 2025. It shall remain effective for a period of [1 year] **2 YEARS** and 1 month and, at the  
18 end of June 30, [2026] **2027**, this Act, with no further action required by the General  
19 Assembly, shall be abrogated and of no further force and effect.

32 **JOINT COMMITTEE ON PENSIONS.**

33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
34 1, 2025. It shall remain effective for a period of [1 year] **2 YEARS** and 1 month and, at the

1 end of June 30, [2026] **2027**, this Act, with no further action required by the General  
2 Assembly, shall be abrogated and of no further force and effect.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
4 1, 2026.
