A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County – Alcoholic Beverages – Multiple Licenses Prohibition –**
3 **Exceptions**

5 FOR the purpose of adding Class B (on-sale) beer and wine and Class B (on-sale) beer,
6 wine, and liquor licenses to the list of alcoholic beverages licenses for which the
7 prohibition against issuing multiple licenses for the same person or premises in
8 Prince George's County does not apply; and generally relating to alcoholic beverages
9 licenses in Prince George's County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Alcoholic Beverages and Cannabis**

23 26–102.

24 This title applies only in Prince George's County.

2 (a) Unless otherwise authorized by this article, a person may not have an interest
3 in more than one license issued by the Board, regardless of whether the person acts on the
4 person's own behalf or on behalf of another person.

5 (b) The prohibition against issuing multiple licenses for the same premises or to
6 an individual for the use of that individual, a partnership, a corporation, an unincorporated
7 association, or a limited liability company does not apply if:

8 (1) each premises is a bowling establishment that has at least 30 lanes with
9 automatic pinsetters; and

10 (2) the licenses were issued before June 1, 1982.

11 (c) The prohibition against issuing multiple licenses for the same person or
12 premises does not apply to a Class B-ECF/DS license, **CLASS B (ON-SALE) BEER AND**
13 **WINE LICENSE, OR CLASS B (ON-SALE) BEER, WINE, AND LIQUOR LICENSE.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
15 1, 2026.
