5 FOR the purpose of repealing the limit on the number of Class B beer, wine, and liquor
6 licenses that the Board of License Commissioners for Prince George's County may
7 issue; and generally relating to alcoholic beverages licenses in Prince George's
8 County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Alcoholic Beverages and Cannabis**

22 26-102.
