A BILL ENTITLED

1 AN ACT concerning

2 **Howard County – Alcoholic Beverages – Gift Basket Permit**

3 **Ho. Co. 2-26**

4 FOR the purpose of establishing, in Howard County, a gift basket permit that authorizes a
5 permit holder to sell and deliver gift baskets containing beer, wine, or liquor to
6 certain individuals under certain circumstances; providing that certain distance
7 requirements do not apply to the issuance of the permit; and generally relating to
8 alcoholic beverages in Howard County.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
25 That the Laws of Maryland read as follows:

4 **23–1003.1.**5 (A) **THERE IS A GIFT BASKET PERMIT.**6 (B) (1) **THE BOARD MAY ISSUE THE PERMIT TO A PERSON:**7 (I) **WHOSE PRIMARY BUSINESS IS THE SALE AND DELIVERY OF**
8 **FLOWERS;**9 (II) **WHOSE BUSINESS INCLUDES THE SALE AND DELIVERY OF**
10 **GIFT BASKETS OF FLOWERS, FOOD, OR OTHER ITEMS; AND**11 (III) **WHO DOES NOT HOLD ANY OTHER ALCOHOLIC BEVERAGES**
12 **LICENSE OR PERMIT UNDER THIS ARTICLE.**13 (2) **THE BOARD MAY NOT ISSUE THE PERMIT FOR USE IN**
14 **CONJUNCTION WITH OR ON THE PREMISES OF A CHAIN STORE, SUPERMARKET, OR**
15 **DISCOUNT HOUSE.**16 (C) **A HOLDER OF THE PERMIT:**17 (1) **MAY SELL AND DELIVER, TO CONSUMERS OF A LEGAL DRINKING**
18 **AGE LOCATED IN THE COUNTY, GIFT BASKETS CONTAINING:**19 (I) **NOT MORE THAN 72 OUNCES OF BEER;**20 (II) **NOT MORE THAN 2.25 LITERS OF WINE; OR**21 (III) **NOT MORE THAN 2.25 LITERS OF LIQUOR; AND**22 (2) **SHALL MAINTAIN RECORDS AND SUBMIT REPORTS AS REQUIRED**
23 **BY THE BOARD.**24 (D) (1) **SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE PERMIT**
25 **HOLDER OR AN EMPLOYEE OF THE PERMIT HOLDER SHALL:**26 (I) **DELIVER THE GIFT BASKET CONTAINING ALCOHOLIC**
27 **BEVERAGES; AND**

4 (2) AN INDIVIDUAL WHO DELIVERS A GIFT BASKET CONTAINING
5 ALCOHOLIC BEVERAGES SHALL BE AT LEAST 21 YEARS OLD.

6 (E) THE HOLDER'S ANNUAL SALES FROM ALCOHOLIC BEVERAGES MAY NOT
7 EXCEED 10% OF THE HOLDER'S ANNUAL GROSS SALES.

8 (F) THE ALCOHOLIC BEVERAGES CONTAINED IN A GIFT BASKET SHALL BE
9 PURCHASED FROM A RETAIL LICENSE HOLDER.

10 (G) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION.

11 (h) THE FEE FOR A GIFT BASKET PERMIT IS \$100.

13 (a) (1) Subject to subsection (b) of this section, the Board may not issue:

14 (i) a Class B license for a restaurant that is within 400 feet of the
15 nearest point of a public school building; or

16 (ii) any other license for an establishment that is within 500 feet of
17 the nearest point of a public school building.

(2) A decision of the County Board of Education to locate a public school building within 500 feet of the premises of a license holder may not be the basis to revoke or deny the renewal or transfer of the license.

21 (b) For a license issued on or before June 30, 1971, the Board may renew the
22 license or approve the transfer of the license to a new license holder for the same
23 establishment and type of license.

24 (c) THE PROHIBITION AGAINST ISSUING A LICENSE IN SUBSECTION (A) OF
25 THIS SECTION DOES NOT APPLY TO THE ISSUANCE OF A GIFT BASKET PERMIT.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
27 1, 2026.
