2 **Election Districts – General Assembly and Representatives in Congress**

3 FOR the purpose of clarifying that certain requirements apply only to districts for the
4 election of members of the Senate of Maryland and the House of Delegates;
5 authorizing the General Assembly to grant original jurisdiction to the Supreme
6 Court of Maryland to review the congressional districting of the State; altering
7 districts for the election of Representatives in Congress for certain elections; and
8 generally relating to election districts.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

12 congressional districting plan set forth in this section shall be used to elect the State's
13 Representatives in Congress from the State's eight congressional districts in 2026.

6 Act and except as provided in Section 7 of this Act, this Act is an emergency measure, is
7 necessary for the immediate preservation of the public health or safety, has been passed by
8 a yea and nay vote supported by three-fifths of all the members elected to each of the two
9 Houses of the General Assembly, and shall take effect from the date it is enacted.
