3 FOR the purpose of extending the time period during which a temporary protective order
4 is effective after service of the order; extending the time period for which a final
5 protective order hearing is required to be held after service of the temporary
6 protective order; ~~providing that a final protective order may order the respondent to~~
7 ~~pay to a person eligible for relief certain losses or expenses incurred as a result of~~
8 ~~abuse; providing that a certain monetary award does not preclude a petitioner from~~
9 ~~bringing a subsequent claim for certain losses or expenses;~~ and generally relating to

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 6 That the Laws of Maryland read as follows:

7 **Article – Family Law**

8 4–505.

9 (a) (1) (i) If, after a hearing on a petition, whether ex parte or otherwise, a
 10 judge finds that there are reasonable grounds to believe that a person eligible for relief has
 11 been abused, the judge may enter a temporary protective order to protect any person
 12 eligible for relief from abuse.

13 (c) (1) Except as otherwise provided in this subsection, the temporary
 14 protective order shall be effective for not more than [7] 14 days after service of the order.

15 (2) The judge may extend the temporary protective order as needed, but
 16 not to exceed 6 months, to effectuate service of the order where necessary to provide
 17 protection or for other good cause.

18 (3) If the court is closed on the day on which the temporary protective order
 19 is due to expire, the temporary protective order shall be effective until the second day on
 20 which the court is open, by which time the court shall hold a final protective order hearing.

22 (a) A respondent under § 4–505 of this subtitle shall have an opportunity to be
 23 heard on the question of whether the judge should issue a final protective order.

24 (b) (1) (i) The temporary protective order shall state the date and time of
 25 the final protective order hearing.

26 (ii) Except as provided in § 4–505(c) of this subtitle, or unless
 27 continued for good cause, the final protective order hearing shall be held no later than [7]
 28 14 days after the temporary protective order is served on the respondent.
