1 AN ACT concerning

2 **State Board of Physicians – Naturopathic Doctors – Scope of Practice,**  
3 **Renewals, and Professional Liability Insurance**

4 FOR the purpose of altering the drugs that may be prescribed, provided, or administered  
5 or for which a ~~start~~ starter dose may be dispensed by a naturopathic doctor; altering  
6 the methods by which a naturopathic doctor may administer medication; ~~renaming~~  
7 repealing the Naturopathic Doctors Formulary Council ~~to be the Naturopathic~~  
8 ~~Doctors Formulary Council for Controlled Dangerous Substances and altering the~~  
9 ~~Council's purpose~~; altering the requirements for renewal of a naturopathic doctor  
10 license; altering the grounds for discipline of naturopathic doctors; requiring the  
11 State Board of Physicians to include certain information regarding professional  
12 liability insurance on a naturopathic doctor's licensee profile; requiring naturopathic  
13 doctors to notify patients in a certain manner, post certain information, and provide  
14 certain verification to the Board on request relating to professional liability  
15 insurance; and generally relating to naturopathic doctors.

 16 **NATUROPATHIC DOCTOR**, or podiatrist from personally dispensing a starter dosage of a

19 (i) The starter dosage complies with the labeling requirements of §  
 20 12–505 of this title;

21 (ii) No charge is made for the starter dosage; and

 23 **DOCTOR**, or podiatrist enters an appropriate record on the patient’s chart.

 10 training and competence demonstrated by passing the naturopathic physician licensing

 14 electrocardiograms with over read by a cardiologist, and physiological function tests;
