4 FOR the purpose of altering the license fee structure for Class C per diem beer, beer and
5 wine, and beer, wine, and liquor licenses issued by the Board of License
6 Commissioners for Anne Arundel County; and generally relating to alcoholic
7 beverages licenses in Anne Arundel County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages and Cannabis**

4 (a) [The] **FOR AN EVENT WITH AN ESTIMATED ATTENDANCE OF FEWER**
5 **THAN 500 INDIVIDUALS:**

6 (1) **THE** fee for a Class C per diem beer license and a Class C per diem beer
7 and wine license is \$25 per day[.]; **AND**

8 [(b)] (2) [The] **THE** fee for a Class C per diem beer, wine, and liquor license is
9 \$50 per day.

10 (B) **FOR AN EVENT WITH AN ESTIMATED ATTENDANCE OF 500 OR MORE**
11 **INDIVIDUALS:**

12 (1) **THE FEE FOR A CLASS C PER DIEM BEER LICENSE AND A CLASS C**
13 **PER DIEM BEER AND WINE LICENSE IS \$25 PER POINT OF SALE LOCATION THAT**
14 **SERVES ALCOHOL AT THE EVENT PER DAY; AND**

15 (2) **THE FEE FOR A CLASS C PER DIEM BEER, WINE, AND LIQUOR**
16 **LICENSE IS \$50 PER POINT OF SALE LOCATION THAT SERVES ALCOHOL AT THE**
17 **EVENT PER DAY.**

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
19 1, 2026.
