## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Health – Licensure of Hospitals – Ownership Requirements**

3 FOR the purpose of requiring that hospitals, to qualify for a license on or after a certain  
4 date, qualify as a nonprofit organization under federal law and be registered as a  
5 nonprofit organization with the State; requiring hospitals that receive licensure on  
6 or after a certain date to maintain status as a nonprofit organization as a condition  
7 of licensure; providing that, on or after a certain date, the ownership of a licensed  
8 hospital may be transferred only to a nonprofit organization; and generally relating  
9 to the licensure of hospitals.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
21 That the Laws of Maryland read as follows:

2 19–319.

3 (a) To qualify for a license, an applicant and the hospital or related institution to  
4 be operated shall meet the requirements of this section.

5 (K) (1) (I) TO QUALIFY FOR A LICENSE ON OR AFTER OCTOBER 1,  
6 2026, THE HOSPITAL TO BE OPERATED SHALL QUALIFY AS A NONPROFIT  
7 ORGANIZATION UNDER FEDERAL LAW AND BE REGISTERED AS A NONPROFIT  
8 ORGANIZATION WITH THE STATE.

9 (II) A HOSPITAL THAT RECEIVES LICENSURE ON OR AFTER  
10 OCTOBER 1, 2026, SHALL MAINTAIN STATUS AS A NONPROFIT ORGANIZATION AS A  
11 CONDITION OF LICENSURE.

12 (2) ON OR AFTER OCTOBER 1, 2026, THE OWNERSHIP OF A LICENSED  
13 HOSPITAL MAY BE TRANSFERRED ONLY TO A NONPROFIT ORGANIZATION.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
15 October 1, 2026.
