2 **Prince George's County – Alcoholic Beverages – Fees**

3 **PG 317–26**

4 FOR the purpose of increasing certain application, license, permit, and license transfer fees

11 (n) The annual fee for the permit is [~~\$1,500~~] **\$1,650**, which is in addition to the  
12 annual fee for the Class B license.

15 (g) The annual fee for the permit is [~~\$250~~] **\$275**, which is in addition to the  
16 annual fee for the Class B license.

20 (2) The annual fees for the permit are:

21 (i) [~~\$2,590~~] **\$2,850** for the holder of a Class A license; and

22 (ii) [~~\$1,080~~] **\$1,190** for the holder of a Class B license with an  
23 off–sale privilege.

24 (3) The fees listed in paragraphs (1) and (2) of this subsection are in  
25 addition to the annual fee for the Class A license or Class B license to which it is attached.

5 (a) There is a wine tasting license.

6 (e) In addition to the cost of the beer and wine license or beer, wine, and liquor  
7 license, the annual license fee is [~~\$120~~] **\$130**.

9 (a) (1) Except as provided in paragraph (2) of this subsection, for a Class C per  
10 diem beer license and a Class C per diem beer and wine license, the fee is [~~\$75~~] **\$100** per  
11 day.

12 (2) (i) For a club holding a gaming event, the fee is [~~\$100~~] **\$125** per  
13 day.

14 (3) For a Class D (3–day) beer and wine license, the fee is [~~\$100~~] **\$125** per  
15 day.

16 (b) (1) Except as provided in paragraph (2) of this subsection, for a Class C per  
17 diem beer, wine, and liquor license, the fee is [~~\$200~~] **\$225** per day.

18 (2) (i) For a club holding a gaming event, the fee is [~~\$150~~] **\$175** per  
19 day.

20 (3) For a Class C (3–day) beer, wine, and liquor license, the fee is [~~\$200~~]  
21 **\$225** per day.

23 (a) The Board shall charge an application fee for a new license.

24 (c) The application fee is [~~\$300~~] **\$400** and in addition to any other fee required  
25 for a license.

26 26–1602.

27 (b) (1) The Board may approve the transfer of one Class B beer, wine, and  
28 liquor license with an off–sale privilege for use in Hyattsville.
