A BILL ENTITLED

1 AN ACT concerning

2 **Health Facilities – Confidentiality of Medical Records – Crisis Pregnancy**
3 **Clinics**

4 FOR the purpose of applying certain provisions of law governing the confidentiality of
5 medical records to crisis pregnancy clinics; and generally relating to confidentiality
6 of medical records.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Health – General**

20 4–301.

21 (a) In this subtitle the following words have the meanings indicated.

22 (h) (1) “Health care provider” means:

[Brackets] indicate matter deleted from existing law.



(i) A person who is licensed, certified, or otherwise authorized under the Health Occupations Article or § 13–516 of the Education Article to provide health care in the ordinary course of business or practice of a profession or in an approved education or training program; or

(ii) A facility where health care is provided to patients or recipients, including [a]:

1. A facility as defined in § 10–101(g) of this article[, a];
2. A hospital as defined in § 19–301 of this article[, a];
3. A related institution as defined in § 19–301 of this article[, a];
4. A health maintenance organization as defined in § 19–701(g) of this article[, an];
5. AN outpatient clinic[, a];
6. A medical laboratory[, a];
7. A comprehensive crisis response center[, a]
8. A crisis stabilization center[, and a]
9. A crisis treatment center established under § 7.5–207 of this article; AND

10. A CRISIS PREGNANCY CLINIC, INCLUDING A MOBILE FACILITY THAT PROVIDES PREGNANCY-RELATED HEALTH CARE AND IS NOT A COVERED ENTITY UNDER THE FEDERAL HEALTH INSURANCE PORTABILITY AND ACCOUNTABILITY ACT.

(2) “Health care provider” includes the agents, employees, officers, and directors of a facility and the agents and employees of a health care provider.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2026.
