2 **Human-Relevant Research Fund – Collection of Contributions – Responsible**
3 **Entity**

4 FOR the purpose of requiring certain research facilities to pay contributions for the
5 Human-Relevant Research Fund to the Department of Agriculture, rather than the
6 Maryland Department of Health; and generally relating to the Human-Relevant
7 Research Fund.

10 Section 24–2301 through 24–2303 and the subtitle “Subtitle 23. Animal Testing and
11 Research Contribution”

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That Section(s) 24–2301 through 24–2303 and the subtitle “Subtitle 23. Animal Testing
22 and Research Contribution” of Article – Health – General of the Annotated Code of
23 Maryland be repealed.

24 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
25 as follows:

26 Article – Agriculture

5 **DEPARTMENT OF AGRICULTURE UNDER 7 U.S.C. § 2143 AND 9 C.F.R. § 2.36.**6 **2-2502.**7 **(A) ON OR BEFORE JANUARY 15 EACH YEAR, BEGINNING IN 2024, EACH**
8 **RESEARCH FACILITY THAT IS LOCATED IN THE STATE AND IS REQUIRED TO SUBMIT**
9 **AN ANIMAL AND PLANT HEALTH INSPECTION SERVICE FORM 7023 SHALL PAY TO**
10 **THE DEPARTMENT A CONTRIBUTION IN THE AMOUNT OF:**11 **(1) \$5,000 FOR UP TO 100 ANIMALS;**12 **(2) \$10,000 FOR MORE THAN 100 BUT NOT MORE THAN 500 ANIMALS;**13 **(3) \$55,000 FOR MORE THAN 500 BUT NOT MORE THAN 5,000**
14 **ANIMALS; AND**15 **(4) \$75,000 FOR MORE THAN 5,000 ANIMALS.**16 **(B) THE AMOUNT OF THE CONTRIBUTION TO BE PAID UNDER SUBSECTION**
17 **(A) OF THIS SECTION SHALL BE BASED ON THE TOTAL NUMBER OF ANIMALS**
18 **REPORTED IN COLUMN F ON THE MOST RECENTLY SUBMITTED ANIMAL AND PLANT**
19 **HEALTH INSPECTION SERVICE FORM 7023.**20 **(C) THE SECRETARY SHALL DISTRIBUTE THE FUNDS PAID UNDER**
21 **SUBSECTION (A) OF THIS SECTION TO THE HUMAN-RELEVANT RESEARCH FUND**
22 **ESTABLISHED UNDER § 10-4D-02 OF THE ECONOMIC DEVELOPMENT ARTICLE.**23 **2-2503.**24 **A RESEARCH FACILITY THAT FAILS TO PAY THE CONTRIBUTION REQUIRED**
25 **UNDER § 2-2502(A) OF THIS SUBTITLE MAY BE SUBJECT TO A CIVIL PENALTY OF NOT**
26 **MORE THAN \$1,000 PER DAY.**27 **SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect**
28 **October 1, 2026.**
