CHAPTER _____

1 AN ACT concerning

2 **Criminal Law – Fraud – Assisted Reproductive Treatment**

3 FOR the purpose of prohibiting a person from intentionally or knowingly providing certain
4 assisted reproductive treatment to another using the person's sperm or ovum
5 without the other's written consent to assisted reproductive treatment using the
6 person's sperm or ovum; establishing a civil cause of action for a violation of this Act;
7 and generally relating to fraud.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Criminal Law**

16 **8–906.**

17 **(A) (1) IN THIS SECTION, “ASSISTED REPRODUCTIVE TREATMENT”**
18 **MEANS A METHOD OF CAUSING PREGNANCY OTHER THAN THROUGH SEXUAL**
19 **INTERCOURSE.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.

Underlining indicates amendments to bill.

~~Strike out~~ indicates matter stricken from the bill by amendment or deleted from the law by amendment.



1 **(2) “ASSISTED REPRODUCTIVE TREATMENT” INCLUDES:**

2 **(I) DONATION OF EGGS OR SPERM;**

3 **(II) DONATION OF EMBRYOS;**

4 **(III) INTRACYTOPLASMIC SPERM INJECTION;**

5 **(IV) INTRAUTERINE OR INTRACERVICAL INSEMINATION; AND**

6 **(V) IN VITRO FERTILIZATION AND EMBRYO TRANSFER.**

7 **(B) (1) A PERSON MAY NOT INTENTIONALLY OR KNOWINGLY PROVIDE**
8 **ASSISTED REPRODUCTIVE TREATMENT TO ANOTHER USING THE PERSON’S SPERM**
9 **OR OVUM WITHOUT THE OTHER’S WRITTEN CONSENT TO ASSISTED REPRODUCTIVE**
10 **TREATMENT USING THE PERSON’S SPERM OR OVUM.**

11 **(2) A PERSON WHO VIOLATES PARAGRAPH (1) OF THIS SUBSECTION**
12 **IS GUILTY OF A FELONY AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT**
13 **EXCEEDING 10 YEARS OR A FINE NOT EXCEEDING \$5,000 OR BOTH.**

14 **(C) (1) A PERSON WHO VIOLATES SUBSECTION (B) OF THIS SECTION IS**
15 **LIABLE FOR CIVIL DAMAGES IN AN ACTION BROUGHT BY:**

16 **(I) THE WOMAN WHO GIVES BIRTH TO A CHILD AFTER**
17 **RECEIVING THE ASSISTED REPRODUCTIVE TREATMENT;**

18 **(II) THE SPOUSE OR DOMESTIC PARTNER OF THE WOMAN WHO**
19 **GIVES BIRTH TO A CHILD AFTER RECEIVING THE ASSISTED REPRODUCTIVE**
20 **TREATMENT; OR**

21 **(III) THE CHILD BORN AS A RESULT OF THE ASSISTED**
22 **REPRODUCTIVE TREATMENT.**

23 **(2) A CHILD BORN AS A RESULT OF ASSISTED REPRODUCTIVE**
24 **TREATMENT PROVIDED BY A PERSON IN VIOLATION OF SUBSECTION (B) OF THIS**
25 **SECTION IS ENTITLED TO A QUALIFIED PROTECTIVE ORDER ALLOWING THE CHILD**
26 **ACCESS TO THE PERSONAL MEDICAL RECORDS AND HEALTH HISTORY OF THE**
27 **PERSON.**

28 **(3) A CIVIL ACTION UNDER THIS SECTION SHALL BE FILED:**

1 (I) WITHIN 10 YEARS AFTER THE CHILD BORN AS A RESULT OF
2 THE ASSISTED REPRODUCTIVE TREATMENT REACHES THE AGE OF 18 YEARS;

3 (II) WITHIN 20 YEARS AFTER THE DAY ON WHICH THE ASSISTED
4 REPRODUCTIVE TREATMENT WAS PROVIDED; OR

5 (III) WITHIN 2 YEARS AFTER THE DAY ON WHICH AN INDIVIDUAL
6 FIRST DISCOVERS SUFFICIENT EVIDENCE THROUGH DNA ANALYSIS THAT THE
7 INDIVIDUAL HAS A CAUSE OF ACTION AGAINST A PERSON UNDER THIS SECTION.

8 (4) A PLAINTIFF WHO PREVAILS IN AN ACTION BROUGHT UNDER THIS
9 SECTION IS ENTITLED TO:

10 (I) THE COSTS OF THE ASSISTED REPRODUCTIVE TREATMENT;

11 (II) ~~LIQUIDATED DAMAGES NOT TO EXCEED \$50,000;~~

12 ~~(III)~~ ECONOMIC AND NONECONOMIC COMPENSATORY DAMAGES;

13 AND

14 ~~(IV)~~ (III) REASONABLE ATTORNEY'S FEES AND COSTS.

15 (D) THIS SECTION MAY NOT BE CONSTRUED TO PROHIBIT A PERSON FROM
16 PURSUING ANY OTHER REMEDY PROVIDED BY LAW.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2026.
