## A BILL ENTITLED

1 AN ACT concerning

2 **St. Mary's County – Prohibition on Standing in Inherently Dangerous Highway**

3 FOR the purpose of prohibiting a person in St. Mary's County from standing in a roadway,  
4 a shoulder, a median divide, or an intersection determined by the county or a  
5 municipal corporation in the county to be inherently dangerous; prohibiting a police  
6 officer from issuing a citation for a violation of this Act unless certain conditions are  
7 met; and generally relating to prohibiting standing in inherently dangerous  
8 roadways, shoulders, median divides, or intersections in St. Mary's County.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

16 **Article – Transportation**

17 **21–507.1.**

18 **(A) THIS SECTION APPLIES ONLY IN ST. MARY'S COUNTY.**

19 **(B) IN THIS SECTION, “INHERENTLY DANGEROUS” MEANS POSING A**  
20 **SERIOUS RISK OF INJURY TO A PEDESTRIAN, A DRIVER OR PASSENGER IN A VEHICLE,**  
21 **OR OTHER PERSONS THAT CANNOT BE MITIGATED WITH THE EXERCISE OF**  
22 **ORDINARY CARE.**

1           **(C) A PERSON MAY NOT STAND IN A ROADWAY, A SHOULDER, A MEDIAN**  
2 **DIVIDER, OR AN INTERSECTION DETERMINED BY THE COUNTY OR A MUNICIPAL**  
3 **CORPORATION IN THE COUNTY TO BE INHERENTLY DANGEROUS.**

4           **(D) A POLICE OFFICER MAY NOT ISSUE A CITATION FOR A VIOLATION OF**  
5 **THIS SECTION UNLESS:**

6                   **(1) THE INHERENTLY DANGEROUS ROADWAY, SHOULDER, MEDIAN**  
7 **DIVIDER, OR INTERSECTION HAS APPROPRIATE SIGNS INSTALLED THAT NOTIFY THE**  
8 **PUBLIC THAT A PERSON MAY NOT STAND IN VIOLATION OF THIS SECTION; AND**

9                   **(2) THE SIGNS ARE INSTALLED IN ACCORDANCE WITH THE MANUAL**  
10 **AND SPECIFICATIONS FOR A UNIFORM SYSTEM OF TRAFFIC CONTROL DEVICES**  
11 **ADOPTED BY THE STATE HIGHWAY ADMINISTRATION UNDER § 25-104 OF THIS**  
12 **ARTICLE.**

13           **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**  
14 **October 1, 2026.**
