## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **State Government – Procedures – Permitting Efficiency for Housing**  
3 **Development Projects**

4 FOR the purpose of requiring certain units in the Executive Branch of State government  
5 to adopt procedures to streamline certain permitting processes for housing  
6 development projects; requiring the State Housing Ombudsman to ensure  
7 consistency between certain permitting processes developed by different units;  
8 authorizing the delegation of certain tasks related to the review or approval of  
9 permits related to housing construction to certain local governmental units; and  
10 generally relating to permitting efficiency for housing development projects.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That Section(s) 10-1701 and 10-1702 and the subtitle "Subtitle 17. Miscellaneous" of  
3 Article – State Government of the Annotated Code of Maryland be renumbered to be  
4 Section(s) 10-1801 and 10-1802, respectively, and the subtitle "Subtitle 18. Miscellaneous".

5 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
6 as follows:

7 **Article – State Government**

8 **SUBTITLE 17. PERMITTING EFFICIENCY FOR HOUSING DEVELOPMENT PROJECTS.**

9 **10-1701.**

10 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
11 INDICATED.

12 (B) "HOUSING DEVELOPMENT PROJECT" MEANS THE NEW CONSTRUCTION  
13 OR SUBSTANTIAL RENOVATION OF A RESIDENTIAL REAL ESTATE PROJECT.

14 (C) (1) "PERMIT RELATED TO HOUSING CONSTRUCTION" MEANS A  
15 PERMIT OR AN APPROVAL REQUIRED BY LAW OR REGULATION TO BE ISSUED BY A  
16 UNIT IN THE EXECUTIVE BRANCH OF STATE GOVERNMENT TO A DEVELOPER,  
17 CONTRACTOR, OR SUBCONTRACTOR IN ORDER TO COMMENCE, CONTINUE, OR  
18 SUPPORT A HOUSING DEVELOPMENT PROJECT.

19 (2) "PERMIT RELATED TO HOUSING CONSTRUCTION" INCLUDES A  
20 PERMIT OR AN APPROVAL RELATED TO THE CONSTRUCTION OR EXPANSION OF  
21 SUPPORTIVE INFRASTRUCTURE SERVING A HOUSING DEVELOPMENT PROJECT.

22 (D) "STATE HOUSING OMBUDSMAN" MEANS THE INDIVIDUAL DESIGNATED  
23 BY THE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT TO  
24 FACILITATE NAVIGATION THROUGH LOCAL, STATE, AND FEDERAL PERMITTING  
25 PROCESSES.

26 **10-1702.**

27 (A) EACH UNIT IN THE EXECUTIVE BRANCH OF STATE GOVERNMENT THAT  
28 IS RESPONSIBLE FOR ISSUING A PERMIT RELATED TO HOUSING CONSTRUCTION  
29 SHALL ADOPT PROCEDURES TO STREAMLINE THE PERMITTING PROCESS IN  
30 ACCORDANCE WITH THIS SECTION.

1           **(B) A STREAMLINED PERMITTING PROCESS ADOPTED UNDER THIS SECTION**  
2 **SHALL, AT A MINIMUM:**

3           **(1) TO THE EXTENT FEASIBLE, ALLOW FOR THE CONCURRENT FILING**  
4 **AND ADJUDICATION OF MULTIPLE PERMITS OR APPROVALS RELATED TO A**  
5 **PARTICULAR HOUSING DEVELOPMENT PROJECT;**

6           **(2) IN CASES IN WHICH CONCURRENT FILING AND ADJUDICATION IS**  
7 **NOT FEASIBLE, PROVIDE FOR THE PREDICTABLE SEQUENCING OF FILINGS AND**  
8 **ADJUDICATIONS; AND**

9           **(3) ESTABLISH A FRAMEWORK THAT ALLOWS FOR THE EXPEDITED**  
10 **REVIEW OF PERMITS RELATED TO HOUSING CONSTRUCTION, INCLUDING CLEAR**  
11 **ESCALATION AND PRIORITIZATION PATHWAYS.**

12           **(C) IN DEVELOPING A STREAMLINED PERMITTING PROCESS UNDER THIS**  
13 **SECTION, A UNIT SHALL CONSULT WITH:**

14           **(1) THE UNIT'S PERMITTING OPERATIONS STAFF;**

15           **(2) RELEVANT STAKEHOLDERS, INCLUDING ENTITIES THAT**  
16 **FREQUENTLY APPLY FOR PERMITS; AND**

17           **(3) THE STATE HOUSING OMBUDSMAN.**

18           **(D) TO THE EXTENT FEASIBLE, THE STATE HOUSING OMBUDSMAN SHALL**  
19 **ENSURE CONSISTENCY BETWEEN THE STREAMLINED PERMITTING PROCESSES**  
20 **DEVELOPED BY DIFFERENT UNITS UNDER THIS SECTION.**

21 **10-1703.**

22           **NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A UNIT IN THE**  
23 **EXECUTIVE BRANCH OF STATE GOVERNMENT MAY, BY AGREEMENT WITH A COUNTY**  
24 **OR MUNICIPALITY, DELEGATE TO AN APPROPRIATE LOCAL GOVERNMENTAL UNIT**  
25 **ANY TASK RELATED TO THE REVIEW OR APPROVAL OF PERMITS RELATED TO**  
26 **HOUSING CONSTRUCTION WITHIN THE COUNTY OR MUNICIPALITY.**

27           **SECTION 3. AND BE IT FURTHER ENACTED, That on or before December 1,**  
28 **2027, the State Housing Ombudsman within the Department of Housing and Community**  
29 **Development shall report to the Senate Committee on Education, Energy, and the**  
30 **Environment and the House Government, Labor, and Elections Committee, in accordance**  
31 **with § 2-1257 of the State Government Article, on the development and implementation of**  
32 **the streamlined permitting processes required by this Act.**
